NARRATIVE

On May 13th, 2024, at approximately 2036 hours, I responded to in reference to a disturbance.

Upon my arrival, I made contact with a Hispanic male who was later identified as Joel Montanez. I also made contact with a white female who was later identified as Rene Haley. Upon speaking with Rene, she stated that while she was at work, she opened her cellphone to look at her security camera. At that time, she observed Joel walk onto her front porch. She then advised that the camera feed was discontinued shortly after. When she arrived on scene, she observed that the cable that supplied power to her security camera was damaged. She then showed me the damage. I observed that the power cable was separated from the power supply. Rene stated that there was a separate cable that was supposed to be connected to the camera. She was not able to locate that cable while I was on scene. When I asked Rene if she wanted to pursue prosecution, she stated that she did.

It should be noted that both subjects were engaged in a romantic relationship with each other which ended the day prior to this incident.

I then approached Joel and read him his Miranda Rights from my agency issued card. Joel advised that he understood his rights but was not willing to speak with me about the incident.

It was determined that probable cause was established that Joel Montanez was in violation of FSS 806.13 (Criminal Mischief). Joel was subsequently placed under arrest and transported to the Indian River County Jail for booking.

NARRATIVE

On 05/13/2024, at approxmatelty 2008 hours, I responded to the 400 block of U.S. Highway 1, in reference to a welfare check.

Prior to my arrival, I observed a male subject riding a bicycle northbound along the roadway, fall down twice and striking his face onto the ground.

The complaint advised, that she was traveling southbound on U.S. Highway 1, when she observed a male subject fall off of his bicycle numerous times onto the ground. When she stopped and made contact with the subject, she could smell the odor of an alcoholic beverage and noticed that he was heavily intoxicated, due to him not being able to stand up on his feet.

Upon making contact with the subject, I observed that he loss his balance and fell onto the ground. Due to standing directly in front of the subject, I could smell the heavy odor of an alcoholic beverage emitting from his body. When I made eye contact with him, I noticed that both of his eyes were bloodshot red and watery. I was able to identify the subject as Jacob Eubanks, from his Florida license.

After seeing Eubank's face was actively bleeding, I made contact with Indian River Fire Rescue who arrived on scene and was refused by Eubanks for medical treatment.

During a brief conversation with Eubanks, he informed me that he has been drinking Vodka, throughout the day and that he recently received a guilty charge of driving under the influence on 08/03/2023, by the Indian River County Sheriff Office. He later advised, that he is currently on probation and he should not be consuming alcohol. Throughout the conversation, Eubanks words were severely slurred and slow. I also noticed a large amount of salvia, around both corners of his mouth.

Next, I informed Eubanks that I would be conducting a D.U.I. investigation, in which he agreed.

During the Horizontal Gaze Nystagmus Exercise, Eubank showed a lack of smooth pursuit in both eyes, with distinct and sustained nystagmus at maximum deviation. I also observed an onset of nystagmus prior to 45 degrees.

On 05/12/24, at 0144 hours, I was dispatched to in reference to a disturbance call. According to the caller "Ashley" she had received messages from her friend Brandi Smith stating she was being attacked by her boyfriend. Complainant, "Ashley" also stated that she had received messages from Brandi stating that her boyfriend was threatening to kill her.

Upon arrival, myself and Ofc. Amburgey #438 approached the front door of the aforementioned residence and began to knock. After a few moments the door was answered by a white female who was later identified as Brandi L. Smith (DOB: 04/01/1984). Ms. Smith appeared frantic and stated as she exited the residence "he's in there." When asked by Ofc. Amburgey who" he " was Ms. Smith stated "Ricky." While speaking with Ms. Smith at the front of the residence she advised that her juvenile daughter was still inside. Ms. Smith was instructed to retrieve her daughter and exit the residence.

Once away from the front of the residence, I spoke with Ms. Smith about what occurred tonight. According to Ms. Smith, on 05/12/24, at approximately 0500 hours she picked "Ricky" up front the Orlando Airport. While speaking with Ms. Smith she identified "Ricky" as Ricky A. Warner (DOB: 10/08/1986) with whom she is in a dating relationship with and live together at Ms. Smith advised at some time after returning home with Ms. Warner, the aforementioned residence she left him at the residence and went to work. Ms. Smith stated that she did not return home until approximately 2030 hours on 05/12/24. Once home, Ms. Smith stated that she was involved in an argument with Ms. Warner over him "destroying the kitchen." Ms. Smith stated at some point while she was home, the argument turned physical and she accused Mr. Warner of choking, slapping, and punching her. Ms. Smith did state while she was being choked by Mr. Warner that she "couldn't breath for a second."

While speaking with Ms. Smith, I observed some injuries to her face and neck. Ms. Smith's injuries consisted of redness and bruising to both sides of her neck, a small laceration to the left side of her jaw, and her bottom lip on the left side appeared to be swollen. Ms. Smith stated that her injuries were caused by Mr. Warner.

After speaking with Ms. Smith and after a short standoff, Ms. Warner exited the residence and was taken into custody without incident. Once in custody, I attempted a post Miranda interview with Mr. Warner. After reading Ms. Warner his Miranda Warning from a prepared text he advised he did not wish to speak with me. Mr. Warner was informed he was under arrest for violation of FSS 784.041(2)(a) Felony battery; domestic battery by strangulation and he was later transported to the Indian River County Jail for booking, processing and to be held without bond.

On scene, Ofc. Ayala #474 issued Ms. Smith a Domestic Violence packet.

This incident was captured on body worn camera and later downloaded into a secure file at the Vero Beach Police Department.


