# PROBABLE CAUSE STATEMENT

AGENCY CASE #: 25-0994 REPORT DATE: 06/05/2025

The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law: 06/05/2025 15:41
On 6/5/2025, officers responded to the area of 2001 US Highway 1 (Walmart) in reference to a suspicious person. The caller advised a male was harassing people in the parking lot and attempted to open the back door to her vehicle. The caller described the male as older with a green mountain dew shirt and blue and white checkered shorts. The caller provided his last known direction of travel in the area of 1929 US Highway 1.
While looking for the male, I was flagged down by an employee at 1921 US Highway 1 (Tax Collector's Office) who stated a male with blood on him entered the office. I walked into the office and immediately recognized the male to be wearing the same mountain dew shirt with the same checkered shorts as described by the original complainant. The male was observed to have scrapes on his knees and soles of his feet with dried blood on them. The male was only observed to be wearing one sandal.
The male identified himself as Randy Moolenar, which was later confirmed through driver license photograph. When speaking with Randy, I informed him we received a call about him at Walmart. Randy spontaneously uttered "I wasn't in the vehicle". Randy continued to speak incoherently and it was difficult to understand what he was saying.
A short while later, K9 Officer Irwin arrived and advised he just observed this same male seated in the passenger seat of a white Chevrolet pickup inside the parking lot, but did not know it was the subject of the call at first. In response, Randy uttered something to the effect of the vehicle being his brother's vehicle. While waiting to speak with the registered owner of the vehicle, Randy was asked if he had a cell phone to call for a ride to which Randy stated he lost it. Ofc. Irwin went to the pickup truck to look for Randy's cell phone. While at the open passenger side window of the pickup, Ofc. Irwin observed Randy's missing, bloody sandal on the passenger floorboard of the vehicle. The vehicle was observed to have the engine running.
While standing next to the vehicle, the agent of the vehicle, Nohmei Cardoso, exited her work and advised the vehicle was her father's, who was currently in Wal-Mart. Nohmei confirmed no other persons were supposed to be inside the vehicle and the vehicle was not running when she left it. Nohmei confirmed the sandal inside the vehicle was not her or her fathers. Nothing else was out of place in the vehicle. Nohmei stated she did not wish for Randy to be arrested for the crimes against her. The sandal was removed from the vehicle and brought to Randy, who had the exact same other missing sandal. The blood stain on it was consistent with the blood stain on Randy's toe.
In conclusion, Randy was offered the opportunity to dispel law enforcement concerns for his conduct. Randy's speech was slurred, incoherent and did not make sense. Randy stated he only drank a single alcoholic beverage two hours prior. Based on the numerous calls/notifications to law enforcement about Randy's conduct and the observations by Officer Irwin, I placed Randy under arrest and transported him to IRC Jail.

### NARRATIVE

On Thursday, June 5<sup>th</sup>, 2025 at approximately 1404 hours, I responded to 1885 58<sup>th</sup> Avenue, Home Depot, in reference to a retail theft.

Upon arrival, I met with Loss Prevention (LP) Barbara S. Eide, she advised that she was monitoring the store when she saw the suspect, Lazaro De Jesus Lleo Velasquez, enter. She advised the suspect was wearing a blue shirt, Khaki cargo shorts and black shoes. Lleo walked to one of the aisles and picked up a 115- Volt Smart Window A/C unit. He then placed it into a basket. He walked into the service desk line where he appeared to be waiting to pay for the item. Lleo then walked out of the store passing all points of sale, showing he had no intentions of paying for the BTU A/C unit.

LP Eide confronted Lleo when trying to walk out of the store, explaining that she was the loss prevention officer. Lleo disregarded her statement and efforts and ran from the store. Lleo was located by Deputy Whittington at 5755 20<sup>th</sup> Street, Walgreens, where he detained Lleo based off of dispatch description.

A show-up was conducted with LP Eide and she was able to positively identify Lleo as the suspect. Lleo was subsequently arrested based on all evidence and video footage.

I was shown footage of the incident, the following are my observations: At 1357 hours, Lleo walks into the store, wearing a blue shirt, Khaki cargo shorts and black shoes. At 1401 hours, Lleo exits the store passing all points sale with the AC unit in his shopping cart.

Home Depot reported the following item stolen/recovered:

14,000 BTU 150 - Volt Smart Window A/C - \$499.00

Based on the information above, I found probable cause to take Lazaro Lleo into custody for Petit theft.

A trespass warning was issued to Juan from Home Depot.

Lazaro Lleo was transported to the Indian River County Jail without incident.

### NARRATIVE

On June 5, 2025, at approximately 2101 hours, I responded to 5001 20th Street, Vero Beach, in reference to a traffic stop.

Upon arrival, I made contact with Cpl. B. McKenzie who advised the following in essence:

"On 06/05/2025, at approximately 2102 hours, Cpl. McKenzie was following behind Indian River Fire Rescue unit 13 who was en-route to Cleveland Clinic. The Rescue 13 was transporting an overdose patient to the hospital. Rescue 13 was traveling northbound on 43rd Avenue attempting to clear the intersection of State Road 60, using their emergency lights and sirens. Cpl. McKenzie observed a gray Kia sedan bearing Florida tag BT82MW traveling westbound who accelerated through the intersection almost striking the ambulance along the passenger side. Cpl. McKenzie also observed the Kia fail to stop for a steady red-light at the time of the incident.

Cpl. McKenzie conducted a traffic stop on the vehicle in the parking lot of 5001 20th Street (Sonny's BBQ).

Upon making contact with the driver of the vehicle, Cpl. McKenzie noticed that the driver was Tanairy Castro-Rios. It should be noted, that Cpl. McKenzie has had previous had contact with Tanairy in a law enforcement capacity and had knowledge that she currently does not have a valid Florida driver's license.

During a brief conversation with Tanairy she apologized for running the red-light and also stated that she is fully aware of her Florida license being suspended, due to her currently on having an Identification card issued to her."

After speaking with Cpl. McKenzie, I searched Tanairy's driver license via DAVID. I discovered Tanairy's driver license was suspended on February 3, 2025 for failure to pay citation (AIH8TKE). Tanairy was provided notice of her suspension on January 13, 2025.

I then read Tanairy her Miranda Warnings via my Miranda Rights Card. Tanairy advised she would speak with me without her lawyer present. Tanairy admitted to driving on her suspended license. She admitted to having knowledge of the suspension.

Tanairy was arrested for violation of Florida Statute 322.34 (2)(A) – Knowingly DWLSR (AEESW3E) She was transported to the Indian River County Jail without incident.

The front seat passenger, who your affiant made contact with, identified herself as Brooke Frost by providing a photograph of her Florida identification card.

Moyer stated she should not be driving at the moment due to her Florida driver's license currently being suspended since 2021. Moyers' driver license was suspended indefinitely for failure to pay a traffic citation.

All occupants were removed from the vehicle. Your affiant asked Moyers for consent to search the motor vehicle, Moyers stated, "yes". Your affiant observed two drinking cups in the cup holders, one being a stainless-steel cup and the other being an orange cup. Located inside of the stainless-steel cup appeared to be soda with ice. Your affiant also noticed a white folded paper at the top of the cup. Your affiant retrieved the paper, once I unfolded the paper, I noticed a clear rock like substance inside of it. Due to my training and experience as a law enforcement officer, I determined the substance was methamphetamine. The substance was field tested and tested positive for the presence of amphetamines in the substance.

Post Miranda, Frost stated Moyers tried to give her drugs prior to the traffic top. Stated the packaging was clear, once Frost denied taking the substance, Moyers placed it in her beverage. Your affiant asked Frost if she was ever arrested for narcotics, she said, "yes". Frost drug of choice was fentanyl and methamphetamine. Frost said she would prefer to smoke the illegal narcotics out of glass pipe with a round bowl at the bottom. It should be noted, inside of Frost's purse was burnt aluminum foil that is consistent with drug users smoking with narcotics.

Deputy Perez transported Frost to the IRC Jail. It should be noted, Frost asked if she would be allowed to use the restroom before entering the jail. Frost was told no and she would be searched and sent through an x-ray machine. Frost begins moving around in the backseat of the patrol vehicle for a brief moment.

Frost was escorted from Dep. Perez' vehicle and into the custody of correction deputies. According to Dep. Perez, after reviewing her axon backseat camera, Frost can be seen taking the handcuffs off, reaching in her shorts to retrieve an unknown item wiping it off and placing it behind the rear back seat. Dep. Perez checked her patrol vehicle and located a glass pipe with a round bowl at the bottom. This was consistent to what Frost said she would use to consume methamphetamines.

# NARRATIVE

On June 6th, 2025, at approximately 0129 hours, I responded to 1180 U.S. Highway 1 to assist Sergeant Hoilett on a suspicious person call. Upon my arrival, I was advised by Sergeant Hoilett that he was approached by a patron at Wawa advising that a male subject was passed out in the driver's seat of a silver jeep in the parking lot. He made contact with the male, later identified as Sean Woods by his Florida Driver's license. Sergeant Hoilett said when he made contact with Sean, he could smell the odor of an alcoholic beverage coming from his person and observed his eyes were bloodshot. Sean was located in the driver's seat of the jeep with the keys in his pocket.

Upon contact with Sean, I detected a strong odor of an alcoholic beverage emanating from his breath as he spoke. I observed that his eyes were bloodshot and glassy. During our interaction, I observed several signs of impairment: Sean's speech was slow, he was slow to respond to my questions, and his eyes were watery. Sean advised me that he had approximately 1 12-ounce beer at Walking Tree brewing in Vero Beach at approximately 9 P.M.

Based on my observations upon making contact with him, I believed Sean was impaired beyond his normal faculties by alcoholic beverages or controlled substances. I provide Sean a chance to dispel my concerns about his impairment on scene.

I asked Sean if he would participate in a series of standardized field sobriety exercises, to which he agreed. I asked Sean a series of medical questions to ensure he could participate in the field sobriety exercises. Sean stated that he ruptured his Achilles approximately 1 month ago. I observed Sean's left ankle was larger than his right ankle. Sean stated he did not have diabetes, did not take insulin, or suffer from any medical issues. Sean denied taking any street drugs today. Sean also advised he is

Due to Sean's injury to his Achilles, he was unable to perform any of the walking exercises.

The following exercises were performed:

- HORIZONTAL GAZE NYSTAGMUS: No resting nystagmus was observed. Equal pupil size and equal
  tracking were noted in both eyes. I observed a lack of smooth pursuit in both eyes; distinct and sustained
  nystagmus at maximum deviation and the onset of nystagmus prior to 45 degrees were observed in both
  eyes.
- I had Sean count backwards from 37 to 23, which he was able to do.
- I then had Sean say the Alphabet from the letter F to N, which he also completed.

Based on my investigation, probable cause exists that on June 6th, 2025, Sean was in actual physical control of a motor vehicle while under the influence of alcoholic beverages and/or a chemical or controlled substance and was impaired beyond his normal faculties, incapable of operating a vehicle safely. Sean was arrested for DUI at 0202 hours. Deputy Sheriff A. Canales advised me that Sean refused to provide a breath sample. Based on the above, I
