The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law:
On 12/10/2025, at 12:07 (Specifically include facts constituting cause for arrest.)

On December 10th, 2025, at approximately 1048 hours, I, Ofc. Z. Dominguez, responded to 800 Royal Palm Blvd to assist Ofc. Aguilar on a traffic stop.

Upon arrival, I spoke with Ofc. Aguilar who informed me that the driver, identified as Supanee Hanchit, ran a stop sign at the intersection of Ponce De Leon Circ. and Royal Palm Blvd. Upon request of Hanchit's driver's license she provided an international drivers license. Hanchit stated that she has been residing in Florida for a few years and that she has been unable to obtain a Florida Driver's license due to immigration issues. I then placed Hanchit under arrest for violation of F.S.S. 322.03(1) (citation #ALZPLIE) operating with a vehicle with no drivers license.

Hanchit was placed in the back of my patrol vehicle and transported to the Indian River County jail for booking,

This incident was captured by my department issued Body Worn Camera (BWC) and uploaded to VBPB Evidence Library.

Det. Maslan responded to the scene and completed an ICE hold (immigration detainer) on Hanchit.

NARRATIVE

On Wednesday, December 10, 2025, at approximately 0934 hours, I responded to Mullinax Ford (488 US Hwy 1) in reference to a stolen vehicle. Upon arrival, contact was made with the sales manager, William Lambert.

Lambert stated a 2025 Kia K5 was stolen off the car lot last night (12/09/2025) at 1800 hours, per surveillance video. Lambert stated the suspect was inside the store yesterday and test drove the vehicle. Lambert stated he discovered a fake key fob was on the dealership's key ring for the vehicle. Lambert stated he believed the suspect swapped out the key fob during the test drive. Lambert stated the salesman helping the suspect never verified the suspect's driver's license. Lambert stated the suspect left the business between 1630-1730 hours, then returned at 1800 and stole the vehicle that was parked on the lot, which was captured on video surveillance. The vehicle was valued at \$24,000. When the suspect was reversing in the stolen vehicle, he struck the front bumper of 2025 black Ford Mustang, which was parked behind the vehicle. The suspect then left the scene of the crash without leaving any of his information. Minor damage was found on the front bumper of the Mustang and the rear bumper of the Kia.

While I was on scene at Mullinax, Budget Rental (930 US Hwy 1) called to report a stolen license plate from their vehicle. The vehicle was a 2025 Toyota Corolla bearing FL tag 21A-YPI. The license plate with the permanent registration was valued at \$500. RTCC ran that tag through FLOCK and discovered it was attached to the stolen Kia that last night when entering I95 northbound from SR-60.

While I was still on scene, I was notified by employees that the Kia was back and parked in the same parking space it was stolen from. This would have occurred within 10 minutes from when that parking space was last seen empty. The vehicle now had another Florida tag attached to it, 55DAUP, which came back to an address in St. Cloud, FL. Video from the business adjacent to Mullinax captured the suspect parking the stolen vehicle, exiting from the driver's seat, and running away from the vehicle, heading north towards US Hwy 1.

Deputies searched the area and located the suspect shortly after, in the area of 1015 Commerce Avenue. The suspect had the same clothing he was wearing when he was captured stealing the vehicle. The suspect took flight when the deputies told him to stop. The deputies were wearing their agency issued sheriff's office uniform and in a marked agency vehicle labeled Sheriff. The suspect was apprehended by a sheriff's office K9.

The suspect was identified as Kenneth Wayne Miller. Miller was in possession of the Kia's key fob as well as (6) other key fobs belonging to a variety of vehicles.

One of those key fobs belonged to a blue BMW 330I, which was parked at Dyer Mazda, which was the business next to where the suspect was apprehended.

Video surveillance showed Miller inside Dyer Mazda yesterday prior to going to the Mullinax dealership. Contact was made with the salesman who helped Miller, and who showed Miller the BMW. During which Miller entered the vehicle and turned the car on by using the key fob. Miller was unable to test drive that vehicle due to him not having a valid Florida driver's license. The dealership discovered a fake replica key fob on their keychain for the BMW when deputies notified them. The stolen key fob was valued at \$650.

Miller admitted to returning to the dealership later that evening and to stealing the vehicle. Miller admitted to swapping out the real key fob for the BMW and replacing it with a fake one, while at Dyer Mazda yesterday. Miller stated the other key fobs he was in possession of were from dealerships in other counties. One key fob belonging to an Audi S class from an unknown Audi dealership in Sanford, FL. Miller stated he stole the Audi key fob months ago. Miller did not provide the locations from where he stole the other key fobs. Miller stated he would purchase the replica key fobs from Amazon and then swap them out while pretending to be a customer at car dealerships.

Miller was charged with grand theft auto, leaving the scene of a crash, no valid DL, (2) counts of petit theft, and resisting arrest without violence.

On Wednesday, December 10th, 2025 at approximately 1410 hours, I responded to Oyster Point Resort (1570 US Highway 1 Sebastian, Florida 32958) in reference to a suspicious person.

Upon arrival, I made contact with Russell Bancroft, the maintenance supervisor, who stated that a male was in the pool completely nude. Russell explained that he watched video surveillance footage of the public hot tub, when he saw a man sitting in the pool nude. Russell then confronted the male and told him he will need to go back to his room, then called the police.

Russell was able to show me the video footage, to which I observed a white male, later identified as Mark Selles, to be sitting in the public hot tub with two females. Once the females began to exit the hot tub, Mark was seen lifting himself up, to which his penis was then being exposed.

Officer Sanchez made contact with the two females that were in the pool, later identified as Ceili Murphy and Chelsea Olsen. Ceili stated that they were in the hot tub when a man got into the hot tub with them. Once they began to get uncomfortable, they started to exit. As Ceili began to turn around towards Mark, she saw his penis above the water.

I then made contact with Zoey Deshay, who stated she was cleaning the pool bathrooms at the time of the incident. Zoey explained that as she was attempting to leave, she saw Mark with one leg propped up completely exposing his penis above the water in the hot tub.

I then made contact with Mark asking him what occurred at the hot tub. Mark explained that he pulled his swim shorts down, because it is more comfortable. Mark stated that he believed no one would see him due to the bubbles above the water.

Due to the victim's statements, paired with the video footage of Mark having his penis exposed in a public place, Mark was charged with two counts of exposure of sexual organs per F.S.S 800.03.

On Wednesday, December 10, 2025, at approximately 1716 hours, I responded to Home Depot, located at 1885 58th Avenue, Vero Beach, FL, in reference to a shoplifting call for service.

Upon arrival, I made contact with Asset Protection (AP) Specialist B. Susan Eide in the AP office. AP Eide already had the suspect, Curtis Daniel Gordineer, detained. AP Eide advised that staff were alerted when Gordineer entered the store, as he had been previously involved in retail thefts and had eluded apprehension on multiple prior occasions.

On today's date, AP Eide and AP Keith Weinberg followed Gordineer to the power tool section. They observed Gordineer reach into a locked screened area where Milwaukee power tools are secured. Gordineer reached through the locked screen, grabbed a Milwaukee power tool, maneuvered the boxed item to the bottom of the display, and forced it out of the secured cage through a gap between the screen and shelf. Gordineer then walked to another aisle, removed the tool from its packaging, and concealed it inside his pants near the zipper area.

Gordineer proceeded to walk past all points of sale without making any attempt to pay and exited the store. Once outside, AP Eide and AP Weinberg apprehended him. Gordineer complied and walked back into the store with them. Near the customer service desk, Gordineer removed the concealed power tool from his pants and handed it to AP Weinberg. After the item was recovered, they escorted Gordineer to the AP office, where I made contact with him.

Deputy M. Baumann arrived shortly thereafter to assist. Deputy Baumann read Gordineer his Miranda Warnings of Constitutional Rights. Gordineer acknowledged understanding his rights and agreed to speak.

Post-Miranda, Gordineer admitted to the theft. He confirmed that he reached into the locked case, removed the power tool, concealed it in his pants, and walked out of the store without paying. (See Deputy M. Baumann's supplemental report for additional details.)

AP Weinberg conducted a check of the area where Gordineer removed the tool from its packaging and recovered the discarded box. Additionally, AP located two other empty Milwaukee tool boxes that they suspected Gordineer had previously stolen during earlier incidents.

AP Eide then reviewed the surveillance footage with me. The video showed Gordineer entering the store with nothing in his hands, walking to the power tool area, and selecting the item as previously described. At a point out of camera view, he concealed the tool and then exited the store past all points of sale without making any attempt to render payment. The video also showed his apprehension outside and subsequent return to the store, where he removed the concealed tool and handed it to AP Weinberg before being escorted toward the AP office.

I contacted The Real Time Crime Center (RTCC) and requested a criminal history check on Gordineer. RTCC advised that Gordineer has three prior theft convictions and one prior grand theft on his record.

Based on Gordineer's post-Miranda admission, the statements provided by AP Eide and AP Weinberg, and my observations of the surveillance video, I determined there was sufficient probable cause to charge him with

On December 10, 2025, at approximately 2229 hours I noticed a blacked out mini bike pass me northbound on 20th Avenue SW, Vero Beach, Florida. The mini bike had no front or rear lights, and was moving quickly north bound.

I attempted to catch up to the mini bike, it began to accelerate and made a right turn onto 2nd Street, then a quick left onto 19th Avenue. Once it approached the intersection of 19th Avenue and 3rd Street, it ran the stop sign as it made a right on 3rd Street and then a left on 18th Avenue where I activated my emergency lights and called out traffic on an All-terrain vehicle. the final stop was at the 400 block of 18th Avenue.

The driver later identified as Travon M. Wiggins, was wearing an all-black mask, helmet, black and white checkered back pack, and black pants. The mini bike was black with yellow hand grips and a red gas tank. I immediately detained Wiggins due to multiple mini bikes fleeing from law enforcement earlier in the day. I informed Wiggins of my reason for the stop.

Wiggins did not have and was never issued a driver's license or identification card which was confirmed through a query by public safety dispatch. Wiggins was read his Miranda rights which he waived and agreed to speak with me. Wiggins was asked if he had anything illegal on his person or his bag. Wiggins didn't say much but gave consent. Wiggins was later asked if he ever had a drivers license and he stated no. Wiggins was also asked if the mini bike was over 50cc, he wasn't sure but stated that he was going over 35 miles per hour.

Based on the fact listed above, Wiggins was in violation of Florida State statute 322.03(1) no valid driver's license never issued, and Florida state statute 320.02(1) operating a motor vehicle without motor vehicle registration.
