


NARRATIVE

On Friday, March 20, 2026, at approximately 2335 hours, I, Deputy M. Neill #6317 responded to [REDACTED] in reference to disturbance.

I made contact with Ms. Ana Silva. She advised that she was in a verbal disturbance with her boyfriend, who was yelling and screaming at her. At the time, she advised he has been verbally abusive towards her and has recently been in fear for her safety as he made statements that she finds concerning, and takes as a threat. Ms. Silva started to record the situation with Mr. Ibrahim Howar. During the argument, Mr. Howar hit Ms. Silva's hand multiple times as it was the hand holding the phone. Ms. Silva advised she was in pain from Mr. Howar hitting her hand.

Ms. Silva did not have any marks or bruises on her hand.

Ms. Silva was able to show me two separate videos of Mr. Howar hitting the phone out of her hand due to him being frustrated that she was recording him. During this time, Ms. Silva was sitting down while Mr. Howar was walking around the residence.

I spoke to Mr. Howar about the incident. He advised that Ms. Silva and him got in to an argument. Because of the argument, Ms. Silva was saying she was going to sleep with another coworker. This upset Mr. Howar. He then hit the phone out of her hand, as he stated she was in his face. Mr. Howar advised he let his anger get the better of him.

Mr. Howar and Ms. Silva are currently in a boyfriend/girlfriend relationship and have been dating for approximately nine months. [REDACTED]

Based on the above statements and evidence, I believe there is probable cause to arrest Mr. Howar for Battery – Domestic Violence, pursuant to FSS 784.03.1a1.

Mr. Howar was placed under arrest and transported to the Indian River County Jail.

NARRATIVE

On Friday, March 20, 2026 at approximately 0241 hours, I responded to the BP gas station located at 8195 20th Street, Vero Beach, FL 32966 in reference to an alarm call.

Prior to my arrival, due to the location of the gas station, I needed to make a u-turn to get to the BP gas station. As I passed the BP gas station, I observed a white male wearing a black shirt and off white shorts on the east side of the building near a drive through window. As I pulled into the gas station after making the u-turn, that same male was observed walking to the north of the building, where I pulled in from.

Upon arrival, I made contact with the male who was later identified as Mr. Moulay Amaziane. I advised Mr. Amaziane we (Indian River County Sheriffs Office) received an alarm call from the business. Mr. Amaziane advised he may have pulled on the front door a little too hard and set off the alarm. I asked why he was over on the side of the building if he knew the business was closed. Mr. Amaziane could not elaborate why he was over on the side of the building. Mr. Amaziane did however, state he was at the business to buy cigarettes.

Moments later Dep. A. Fettig arrived on scene and waited with Mr. Amaziane as he retrieved his driver's license for identification. While Dep. Fettig remained with Mr. Amaziane, I went over to the drive through window area and observed the following: a cracked window, the sliding window slightly (approximately 2-3 inches) ajar, a broken piece of pallet wood on the window sill, a broken piece of pallet wood on the floor near the window and fresh handprints on the window.

I returned to Dep. A. Fettig and Mr. Amaziane and I read Mr. Amaziane his Miranda rights from my agency issued "Warning of Constitutional Rights" card. After Reading Mr. Amaziane his rights he agreed to speak with me. I asked Mr. Amaziane again why he was over on the side of the building as I discovered a broken and ajar window. Mr. Amaziane advised he was yelling into the business because he knew the clerks.

I then asked Mr. Amaziane if he would come over to the side of the building in an attempt for him to explain the wood and broken window I previously observed. When Mr. Amaziane was asked about the pallet wood near the window and on the floor he stated it must have already been there. Mr. Amaziane could also not explain the broken glass and made an utterance along the lines of the glass was also already broken.

I then made contact with the business manager, Mr. Mohamed Nayeem, via telephone and inquired with him about the drive through window. Mr. Nayeem stated he checks that window every night after closing the store and stated the window was not broken nor ajar. Mr. Nayeem stated he had a camera facing that window and the front door and would review the footage. Moments later Mr. Nayeem, utilizing the Axon Community Share feature, uploaded two camera footage videos to the Axon server.

In this camera footage, Mr. Amaziane can be seen wearing the same black shirt, off white shorts and black shoes, pulling on the front door with excessive force and after not being able to open the door he walks to the right of the camera frame which is to the east side of the building. The next video shows Mr. Amaziane, in the same black shirt and off white shorts, attempting to open the drive through window with his hands, push on the window excessively, grab a piece of wood and

pry the window and at one point it appears as though he kicks the window.

Both these evidentiary videos have conclusive time stamps with the alarm call received by the Indian River County Sheriffs Office Communications Center and Deputies arrival.

After reviewing the footage, I once again made contact with Mr. Amaziane and asked him about what he was doing on the side of the business. Mr. Amaziane simply stated he was just yelling into the business. Mr. Amaziane continued to deny breaking the window, using a piece of wood to pry the window and any other involvement other then yelling into the business from the window.

I showed Mr. Amaziane a small portion of the camera footage and Mr. Amaziane expressed the person in the video was not him.

I confirmed with Mr. Nayeem he wished to pursue criminal charges and inquired the monetary amount of the drive through window replacement. Mr. Nayeem priced the repair at no less than \$2000.00.

Mr. Nayeem's identity was confirmed by him providing his Florida Driver's license number.

I have probable cause to believe Mr. Amaziane did attempt to burglarize (F.S.S. 777.04.1) the BP gas station located at 8195 20th Street, Vero Beach, FL 32966 and in doing so he committed criminal mischief (F.S.S. 806.13.1b3) by breaking the drive through window.

Mr. Amaziane was subsequently placed under arrest utilizing my department issued handcuffs where I ensured proper fit and tightness before double locking. Mr. Amaziane was then transported to the Indian River County Jail Complex without issue.

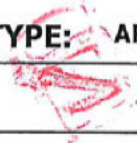

The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law:
On 03/20/2026, at 05:35 (Specifically include facts constituting cause for arrest.)

On March 20th, 2026, at approximately 0433 hours, I, Ofc. Z. Dominguez, responded to 692 21st Street (Miracle Mile Plaza) in reference to a suspicious person.

Upon arrival, I was met by the defendant, later identified as Werner Ruegner. Ruegner advised he was given permission to sleep there by a business owner. Although I explained to Ruegner that he was verbally warned and a signature wasn't necessary, Ruegner claimed that any prior trespass warnings given were invalidated due to him not signing them. I was then informed by VBPd dispatch that there was an active trespass warning on file for Ruegner from 03/06/2026 covering the entire plaza.

Ruegner was then placed under arrest for Trespass After Warning, in violation of F.S.S. 810.09(2)(a). Ruegner was turned over to Indian River County Jail for booking, \$150 bond.

This incident was captured by my department issued Body Worn Camera (BWC) and uploaded to VBPd Evidence Library.

On March 20, 2026 at approximately 1236 hours, I responded to 5555 20th Street, Vero Beach (Walmart) in reference to a retail theft.

Upon arrival I made contact with loss prevention, who were actively following a white female later identified as Lisa F. Haar. Lisa has gray hair, and was last seen wearing black pants and a black jacket who was witnessed taking items from the store and concealing them in her purse. Loss prevention was following her movements with video cameras, as well as one of the loss prevention officers was following the female on foot through the store.

Once on the toy isle, she concealed the rest of the items in her shopping cart into the reusable shopping bag. Lisa then made her way to the front of the store, where she left the shopping cart and walked to the exit doors. Lisa passed all points of sale and was almost out of the building when I stopped her. I removed the two large bags from her person and placed her into physical hand restraints.

She ultimately ended up at Walmart and in her words "one thing led to another and I regret what I did". Lisa stated she used the glass pipe to smoke crack, and she uses every other day.

NARRATIVE

On Friday, March 20th, 2026 at approximately 1445 hours I was traveling westbound on County Road 510 (85th Street) approaching 64th Avenue. As I approached 64th Avenue I observed a black 2014 Dodge Charger bearing FL Tag #RBBU63 approach County Road 510 from 64th Avenue facing south. The Charger turned left directly in front of my patrol vehicle violating my right of way and forcing me to slam on my brakes. Had I not applied my brakes I would have collided with the Charger. There was also traffic traveling eastbound on County Road 510 that the Charger turned in front of.

Paul provided me a Florida ID card, the vehicle title, and a bill of sale. Paul stated that he was driving to the DMV to register the vehicle and renew his driver's license. Paul admitted that the vehicle was not currently registered and that he did not currently have a valid driver's license.

I reviewed the bill of sale and the date of sale to Paul was on 12/06/2025 at 07:25 hours. The hand written name on the bill of sale was Alexander Brown, which is the same name on the title, to the defendant, Paul. The date listed on the title to transfer to Paul is 12/10/2025.

A query through FCIC/NCIC and D.A.V.I.D. of the Charger's VIN number revealed that the Charger was unregistered. A query through NCIC/FCIC of the attached license plate, FL #RBBU63, revealed that the license plate was not assigned to any vehicle. A history search revealed that it was previously registered to this Charger however the tag has since been re-assigned.

NARRATIVE

On Friday, March 20, 2026, approximately at 2305 hours, A traffic stop was conducted in the 4400 block of 43rd Avenue on a silver Toyota, bearing FL tag JKCC68.

I made contact with the sole occupant and driver of the vehicle. The driver was later identified by his Florida drivers license as Richard J. Frangione. Frangion immediately exited the vehicle to ask why was he being pulled over. I explained to Frangione that this was a traffic stop and explained the reasoning for the traffic stop.

Frangione was directed to provide a valid driver license for the traffic stop. Frangione retrieved his wallet from his pocket to display his Florida drivers license and then closed his wallet. I requested Frangione to take the I.D. card out of his wallet, at which he declined to do so. Frangione then stated he has the right to refuse to provide his drivers license to myself.

Once it was explained to Frangione that he does not have the right to refuse, he proceeded to enter his vehicle for a document for myself to fill out. I gave Frangione an additional warning stating, "If you fail to provide me with your driver's license then you will go in handcuffs".

At this point, Frangione continue to disobey all orders and commands which resulted in your affiant attempting to place Frangione's hands behind his back. While this was being executed, Frangione made an attempt to enter the vehicle once again. For my safety, I grabbed Frangione by his shirt and threw him on the ground to gain compliance until responding units arrived.

It should be noted, Frangione was stopped for a minor traffic infraction (no safety belt).

The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law: On 03/20/2026, at 20:32 (Specifically include facts constituting cause for arrest.)



On 03/20/2026, at approximately 20:32 hours, I was on routine patrol when I observed a white Tacoma Truck operating in an unsafe manner. I first witnessed the truck fail to come to a complete stop at the intersection of Azalea Lane and Cardinal Drive. After rolling through the stop sign, the truck accelerated westbound through a residential road. I pulled behind the truck and then observed that the truck had an expired temporary tag displayed (FL #DZN9231, which expired on 03/14/2026). I subsequently conducted a traffic stop on the vehicle near Highway A1A and Bougainvillea Lane.

Once the vehicle was stopped, I approached the vehicle and spoke with the driver/registered owner of the vehicle, Cody Ingrahm. I advised Mr. Ingrahm the reason for the stop and he did not have a normal reaction. Mr. Ingrahm was slow to respond to me and had a grin on his face. Mr. Ingrahm's responses were delayed as he struggled to find the paperwork for his vehicle. While speaking to Mr. Ingrahm, I detected a strong odor of alcohol emanating from inside of the vehicle and from his breath. Mr. Ingrahm had glassy eyes, bloodshot eyes, and a dark stain on his pants due to Mr. Ingrahm urinating on himself. Mr. Ingrahm advised me that he consumed some alcoholic beverages earlier this evening while at the Boiler Bar. When Mr. Ingrahm provided me his license, I observed that he had a "2-Interlock Device" restriction which stemmed from a previous DUI arrest. I discovered that Mr. Ingrahm's Tacoma did not possess an interlock device, and he advised me that he was aware of this and had more than one vehicle.

Based on my observations, I was concerned that Mr. Ingrahm was impaired, and I asked Mr. Ingrahm to perform a series of standardized field sobriety exercises to determine if he was able to safely operate a motor vehicle. Mr. Ingrahm agreed to perform the exercises. I then explained and demonstrated each exercise before having Mr. Ingrahm perform them. I additionally had Mr. Ingrahm acknowledge that he understood each exercise before having him perform them. I observed the following:

Horizontal Gaze Nystagmus:

- Resting nystagmus was not present and Mr. Ingrahm's pupils were equal in size.
- I observed distinct and sustained Nystagmus at maximum deviation in both eyes.
- I did observe the lack of smooth pursuit in both eyes.
- I observed the onset of nystagmus prior to 45 degrees in both eyes.

Walk and Turn:

- Mr. Ingrahm had poor balance and could not maintain the starting position. While providing instructions, Mr. Ingrahm stood with his feet shoulder width apart and not in the correct starting position.
- When instructed to start, Mr. Ingrahm quickly performed the first series of steps forward. Mr. Ingrahm failed to touch his heel to his toes on all the steps forward as he rushed through the exercise. Mr. Ingrahm did count out loud in the appropriate manner while performing the exercise, but he displayed very poor balance as he was shaking.
- Mr. Ingrahm used his arms for balance for most of this exercise. Mr. Ingrahm performed an improper turn and then exceeded nine steps on the way back.

One Leg Stand:

- Mr. Ingrahm was unable to maintain his balance to perform the exercise. Mr. Ingrahm used his arms for balance, and he performed an awkward squat where he bent at his knees and kept his raised leg spread away from his leg that was planted on the ground. Mr. Ingrahm lost his balance and touched the ground three times. Mr. Ingrahm counted in the correct manner, but he lost his count multiple times while performing the exercise.

At this time, based on the totality of my observations, I placed Mr. Ingrahm under arrest at 23:37 hours for driving under the influence of alcohol. The entirety of the field sobriety exercises was captured on my body worn camera and the dash camera on my patrol vehicle.

At 23:48 hours, I transported Mr. Ingrahm to the Indian River County Jail. Once at the Indian River County Jail, I completed a twenty-minute observation period on Mr. Ingrahm. Mr. Ingrahm was then walked to the Intoxilyzer room at the Indian River County Jail. Corrections Deputy, Deputy Canales, was present with me as the breath test was performed. At approximately 00:24 hours, Mr. Ingrahm provided me with two samples of his breath with the alcohol content of 0.192 and 0.197 g/210L. I issued Mr. Ingrahm FL DUI UTC (AFVKKHE) for violation of FSS 316.193(1A) Driving Under the Influence of Alcohol.

Mr. Ingrahm was then transferred to the Indian River County Jail.

PROBABLE CAUSE STATEMENT

On 21 March 2026, at approximately 0035 hrs, while on routine patrol in the 100 block of Englar Street, in the city of Sebastian, I observed a silver GMC pass me bearing FL license plate 19BBXT. As the vehicle passed, I checked my driver's side mirror and observed that the tag light was not illuminated.

I turned on the vehicle and caught up to it in the 200 Block of Englar Drive. I proceeded to shut my headlights off while we were both stopped at the stop sign of Barber Street and Englar Drive. I confirmed there was no tag light, and the tag was not visible from a distance of 50 feet.

Once at the window, I could smell the odor of an alcoholic beverage emitting, in the center console I observed two cans of Budweiser, one being opened and the other closed. They were both wet from sweat. I requested the driver, identified as Luis Alberto Fuentes, to provide his driver's license, which he provided. There was a passenger in the passenger seat.

Due to the alcoholic beverages and the smell of an alcoholic beverage emitting from his breath when he spoke, I asked him how much he had to drink tonight, and he replied, "quite a few". I then asked him who the beer in the center console belonged to, and he stated it was mine. I asked if both belonged to him, and he stated yes. I again asked if he was owning them, and he replied yes, they're all my beers.

At this time, Ofc. Sanchez arrived on scene to assist. I requested Mr. Fuentes to exit the vehicle and walk to the front of my car, which he complied with. At my vehicle, I requested him to provide field sobriety exercises. He stated, "No, because you already know". I told him I was giving him the option, and he replied, "I know you're giving me an option, but you already know, I've been drinking."

At this point, I requested him to turn around and placed him under arrest for driving while intoxicated. I Mirandized him and again asked how much he had to drink, and again he stated I have had quite a few. I made contact with the Defendant who was highly intoxicated. The Defendant advised he had discovered his wife (Sarah Frye) had been cheating on him. When asked, the Defendant advised nothing physical had happened between he and Frye.

Contact was made with his cousin (Lissette Viana) who advised that the Defendant was upset because of the recent discovery that Frye had been cheating on him. Frye and the Defendant were staying in different rooms and the Defendant entered Frye's room to confront her. A verbal altercation ensued. During this, the Defendant "grabbed" Frye. Viana did not witness anything further.

I then spoke with Frye who advised the following: She and the Defendant have been married for the past 14 years and have two children together. [REDACTED] to an upcoming divorce. During this evening, the Defendant entered into Frye's bedroom, via the closed door. Frye was lying in bed and sat up. During the verbal altercation, the Defendant smacked her on the side of the face with an open hand. Frye tried to call police but was stopped by family members.

While speaking with Frye, I noted a red mark on the left side of Frye's face, consistent with being smacked. Frye was offered and declined to have EMS respond. Fry was issued, and signed for, a copy of the Domestic Violence Legal Rights and Remedies packet, including the lethality assessment form.

The Defendant was taken into custody and transported to the Indian River Jail for processing.

NARRATIVE

On March 21, 2026 at approximately 1102 hours, I conducted a traffic stop at the 4300 block of 4th Street, Vero Beach in reference to a driver not wearing a seatbelt.

While conducting routine traffic enforcement, I observed a white in color Chevrolet Pickup, driven by a white male later identified as Gene Franklin identified by his Florida ID card. While westbound on 4th Street from the 2700 block, I observed the white Chevrolet pickup at the stop sign of 38th Ave and 4th Street. The vehicle was waiting to turn westbound, as I passed the vehicle, the drivers window was completely rolled down, Gene was leaned forward observing traffic flow. While leaned forward I could clearly see he was not wearing a seatbelt. The vehicle then turned into traffic westbound behind me, as we approached the traffic control light at 43rd Ave and 4th Street, the truck merged into the left turn lane to travel southbound on 43rd Ave.

I got over behind the truck, I observed Florida tag attached to the rear bumper # QZBS21, the traffic light turned yellow, Gene then pulled into the intersection and made the left turn. Now traveling southbound on 43rd Ave, I activated my emergency lights on my patrol vehicle. Gene signaled he was pulling over, finally coming to a stop at the Trading Post at 175 43rd Ave, Vero Beach.

I exited my patrol vehicle and made contact with the driver Gene Franklin at the driver's door. I informed Gene of the violation, to which he was now wearing a seatbelt, and stated he was always wearing one. I requested his driver's license, Gene became upset and stated he didn't have a valid license before handing me his Florida ID card. I then began to ask about the children in the vehicle, he stated he was with his three sons ages 4,3 and 14. The two toddlers were not in an approved car seat at the time of the traffic stop.

As I continued asking Gene about where he was headed, he stated was going to pick up mattresses for the kids, I asked for the registration for the truck, Gene explained to me that the truck he was driving was not currently registered, the tag on the truck belonged to his fiancé's car, because the truck has a salvage title and he didn't have a license yet to be able to register the vehicle. When asked about the tag attached to the vehicle, he stated he put the tag on the truck because he needed the truck to pick up the mattresses.

I then ran Gene through FCIC/NCIC via dispatch, they advised that Gene's license was suspended as of September 25, 2024, also labeled as a habitual traffic offender as of September 25, 2024. I also ran the VIN 2GCEC19V611143185, through FCIC/NCIC which dispatch informed me that the vehicle was owned by Gene and there is not a registration attached to the vehicle.

Gene was subsequently placed into physical hand restraints and transported to the Indian River County Jail.

Gene is being charged with one count of Driving while license suspended habitual traffic offender for willfully and intentionally operating a motor vehicle while license suspended with a habitual status with knowledge.

On _____, at _____ (Specifically include facts constituting cause for arrest.)

On 03/21/2026, at approximately 1520 hours, I was dispatched to _____ in reference to a disturbance/fight. While enroute, Sebastian Communications advised the complainant, later identified as Sarah Frye, stated her ex, later identified as Luis Viana, was currently at her home. Sebastian Communications further advised Sarah stated Luis was there to pick-up some of his belongings however, he was supposed to have law enforcement with him due to a no-contact order (it should be noted this was later confirmed through Sebastian Communications).

Upon arrival, Sergeant Richard made contact with Sarah, who stated Luis went inside of the RV in her drive way. Sergeant Richard and I proceeded to make contact with Luis, at which point he was detained and placed into mechanical restraints that were double locked and checked for proper fit. Luis was subsequently placed into my patrol vehicle, where I read him his Miranda rights, to which Luis stated he understood.


Luis stated the following in summary post Miranda: Before he left the jail, he was informed of the conditions of the no contact order. He understood that he is not to contact Sarah, and he is not allowed to go to her house _____. Luis went to Sarah's house today because he needed his personal belongings but, Sarah would not let him in the house until law enforcement arrived.

Sarah stated the following in summary via sworn written statement: Sarah was at home, and Luis came to her door (she knew it was him by looking through the peephole) requesting to come inside. Sarah told Luis that he was not allowed back into the house without law enforcement. Luis requested for Sarah not to call the police, and to let him inside the home again, to which Sarah declined and contacted law enforcement.

Based on my observations on scene and the statements made by Sarah and Luis post Miranda, I found there is sufficient probable cause to charge Luis for being in violation of FSS 921.244: ORDER OF NO CONTACT. Luis was in violation of the no contact order by being within 500 feet of Sarah and her residence, and Luis had direct contact with Sarah at her door.

I placed Luis under arrest for the above and transported him to the Indian River County Jail without incident. It should be noted that at the jail, I was provided a physical copy of the conditions of Luis' bond (this included the conditions of the no contact order) which was signed by him.

 On **03/21/2026** , at **19:35** (Specifically include facts constituting cause for arrest.)

On **03/21/2026**, at approximately **19:35** hours, I was on routine patrol near the intersection of **27th Avenue** and **20th Street**. I was in the lane adjacent to a blue Toyota sedan (FL tag #**IH28GY**). The Toyota had the front window rolled down and I observed a female operating the vehicle. I immediately recognized this female as **Natalie Velasquez** (H/F DOB: **09/05/1983**), who I personally know from previous law enforcement investigations. I had existing knowledge that Ms. Velasquez 's license was suspended indefinitely.

I maintained visual on the vehicle while I verified that Ms. Velasquez's license was still suspended. An Inquiry through ELVIS advised me of the following:

I subsequently conducted a traffic stop on the vehicle near the 3400 block of US-1. I approached and made contact with the sole occupant, Ms. Velasquez. I then requested for Ms. Velasquez to provide me with the paperwork for the vehicle and her license. Ms. Velasquez advised me that she had knowledge that her license was suspended and claimed that the only reason she was driving was because the registered owner was in the hospital at Indian River Cleveland Clinic. Ms. Velasquez told me that she was simply trying to bring the vehicle to the registered owner at the ER.

I then checked the credibility of this claim, and I discovered that the registered owner was in fact not a patient at the hospital. I was able to speak with the registered owner over the phone to discuss the matter further. During this phone call, the registered owner confirmed that Ms. Velasquez's claim was not true, and that Ms. Velasquez tried to have the registered owner lie to corroborate her claim. The registered owner verified that they were at their residence, and they advised that they did not know that Ms. Velasquez was prohibited from driving.

I had Ms. Velasquez exit from the vehicle and placed her under arrest for knowingly operating a vehicle with a suspended/revoked license. In the vehicle, I observed and retrieved a liter of Vodka Liquor that was within reach of Ms. Velasquez behind the center console. The bottle was wrapped in a brown paper bag, and I discovered that the cap to the bottle was opened. The bottle was still full, with only a small amount of liquid missing. I did not observe any signs of impairment from Ms. Velasquez, and I could not detect the odor of alcohol because she was smoking cigarettes at the time of the stop.

While inquiring into Ms. Velasquez's driving history, I found out via DAVID that she had three prior guilty convictions for driving on a suspended license, in addition to two DUI offenses. Based on these findings, this arrest would be Ms. Velasquez's fourth subsequent offense. Ms. Velasquez was also actively on probation (until 03/08/2031) under a separate alias of "NATALIE V. KILBOURNE" from a previous marriage. While inquiring on her probationary status, I discovered that Ms. Velasquez was on probation/inmate release for trafficking in stolen property (reference case #K82589).

Based on the totality of the above, Ms. Velasquez was arrested and charged with Felony DWLS (in violation of FSS 322.34). I transported Ms. Velasquez to the Indian River County Jail for booking and processing.

PROBABLE CAUSE STATEMENT

On March 21st, 2026, at approximately 2121 hours, I was dispatched to Walmart at 2001 US Highway 1 in reference to shoplifting.

Upon arrival, I made entry into the loss prevention office at Walmart. I made contact with Dawn Ethier, the loss prevention associate with Walmart. Dawn had a male and a female in the office with her when I arrived.

Dawn provided me with a sworn written statement which stated the following: "I, APA Dawn Ethier, working Loss Prevention for the Sebastian Florida Wal-Mart store #1068 was notified by the door host that a couple that is known to take trading cards and select other items and place them on top of the cards in the cart and when checking out does not attempt to scan the cards. This couple came in and went to the trading cards and selected cards and then went to the chemical isles and selected cleaning items, then to infants where they both selected baby apparel and when checking out the female took the infant clothes and placed them in the front of the cart and placed bags on top of them. After rendering payment, the couple exits out of the grocery door passing all points of sale with the unpaid items. Myself and my witness approach the couple and I announce who I am and ask them to come back inside with me. The items that were not paid for were from the trading card section, infant clothes and some cleaning items. The amount for this incident is \$428.69."

I then spoke with the male who was identified as Sonny Marks. I read Sonny his Miranda rights, to which he understood and wished to continue speaking with me. Sonny said what he did was really stupid. He said that he took trading cards and clothes and put them in his shopping cart. He said that he then passed all points of sale and exited the store without paying for the items.

I then spoke with the female who was identified as Ruby Johnson. I read Ruby her Miranda rights, to which she understood, and she did not want to speak with me. It should be noted that Ruby has been arrested before for felony theft. This was confirmed through a criminal history check run by the Sebastian Police Department dispatch.

Due to evidence and statements that were made, Sonny was placed under arrest for 1 count FSS 812.014(2F) Petit Theft. Ruby was placed under arrest for 1 count FSS 812.014(3B) Petit Theft prior conviction.

Sonny and Ruby were both transported to Indian River County Jail without further incident.

On March 21st, 2026, at approximately 2121 hours, I was dispatched to Walmart at 2001 US Highway 1 in reference to shoplifting.

Upon arrival, I made entry into the loss prevention office at Walmart. I made contact with Dawn Ethier, the loss prevention associate with Walmart. Dawn had a male and a female in the office with her when I arrived.

Dawn provided me with a sworn written statement which stated the following: "I, APA Dawn Ethier, working Loss Prevention for the Sebastian Florida Wal-Mart store #1068 was notified by the door host that a couple that is known to take trading cards and select other items and place them on top of the cards in the cart and when checking out does not attempt to scan the cards. This couple came in and went to the trading cards and selected cards and then went to the chemical isles and selected cleaning items, then to infants where they both selected baby apparel and when checking out the female took the infant clothes and placed them in the front of the cart and placed bags on top of them. After rendering payment, the couple exits out of the grocery door passing all points of sale with the unpaid items. Myself and my witness approach the couple and I announce who I am and ask them to come back inside with me. The items that were not paid for were from the trading card section, infant clothes and some cleaning items. The amount for this incident is \$428.69."

I then spoke with the male who was identified as Sonny Marks. I read Sonny his Miranda rights, to which he understood and wished to continue speaking with me. Sonny said what he did was really stupid. He said that he took trading cards and clothes and put them in his shopping cart. He said that he then passed all points of sale and exited the store without paying for the items.

I then spoke with the female who was identified as Ruby Johnson. I read Ruby her Miranda rights, to which she understood, and she did not want to speak with me. It should be noted that Ruby has been arrested before for felony theft. This was confirmed through a criminal history check run by the Sebastian Police Department dispatch.

Due to evidence and statements that were made, Sonny was placed under arrest for 1 count FSS 812.014(2F) Petit Theft. Ruby was placed under arrest for 1 count FSS 812.014(3B) Petit Theft prior conviction.

Sonny and Ruby were both transported to Indian River County Jail without further incident.

On 03/21/2026, at approximately 22:23 hours, I was traveling directly behind a Chevy Trailblazer (displaying FL tag #CL07CT). I conducted an inquiry on the tag and I discovered that the tag attached to the Chevy was actually registered to a silver Infiniti sedan out of Barefoot Bay, FL. The sedan had no insurance on file, and the registered owner, Cindy Fink, had a suspended license with a seize tag order for her vehicle.

I conducted a traffic stop on the vehicle near the intersection of 27th Avenue and 20th Street. When the vehicle came to a stop, I made contact with the driver, Cindy Fink, and her male passenger. The male passenger claimed he did not have his identification card, and he was reluctant to give me his name. The male told me that he was "Scott" and didn't provide me with his last name.

I subsequently found out that "Scott" was the driver's husband. I then was able to find out the identity of "Scott" by finding his booking images on the Indian River County Jail. From the bookings, I was able to positively identify "Scott" as Scott D. Fink (W/M DOB: 10/28/1963). Scott eventually admitted to me that he refrained from giving his name because he believed he failed to appear for a court appearance.

A records check on Scott revealed that he had warrants for his arrest out of Indian River County (reference case #312024CF000551AXXXVB). At 22:52 hours, a hit confirmation was received for the warrants and I placed Scott under arrest. He was subsequently transported to the Indian River County Jail for booking and processing.

NARRATIVE

On Saturday, March 22nd, 2026 at approximately 2349 hours, I responded to the intersection of 9th Street SW/ US Highway 1 in reference to crash with a driver leaving the scene. Prior to my arrival, dispatch advised that the caller described the vehicle as a black Ram pickup truck.

Upon arriving at the intersection of 9th Street SW and US Highway 1, I observed a black Ram pickup truck bearing Florida temporary tag EAB9683 turning west onto 9th Street SW. Recognizing that this vehicle was the subject of my attention, I initiated a traffic stop by activating my marked agency-issued vehicle's emergency lights and siren at the 900 block of US Highway 1. The driver activated his left turn signal and indicated an intention to stop. However, the vehicle proceeded past the intersection of Old Dixie Highway, continuing west on 9th Street SW. Notably, there was a well-lit parking lot to the right at Old Dixie Highway, which would have been a suitable location for the vehicle to stop. Instead, the driver continued to proceed, refusing to stop the vehicle. At some point, Deputy Ciofalo approached the driver's side window to showing our intent to pull him over. The vehicle then came to a stop, blocking traffic in the middle of the lane.

Deputy Ciofalo and I conducted a felony traffic stop and safely removed the driver from the vehicle. During the search of his person, I immediately detected a strong odor of alcohol emanating from his breath, and his eyes appeared bloodshot and glassy. The driver could barely stand without assistance, and he was unable to follow simple instructions, repeating the same sentences multiple times and demonstrating a lack of comprehension regarding his arrest despite being informed on several occasions. Deputy T. Goodrich advised that the driver-side of the truck had been struck from the rear, with damage consistent with a collision on the right side, which aligned with the description provided, as the other vehicle's damage was on the left side. On scene, I observed damage on the rear right side of the pickup truck matching Deputy Goodrich's description. The driver, later identified as Tremayne L. Barton, initially refused to provide law enforcement with his legal name. Mr. Barton was subsequently placed into the agency's marked patrol vehicle and transported to the Indian River County Jail for processing.

At the jail, I inquired whether Mr. Barton wished to participate in Standardized Field Sobriety Exercises. He declined to do so. I advised Mr. Barton of his Miranda rights, including the Taylor Warnings, but he also refused to participate in the exercises. Once in the custody of jail staff, he was administered the state alcohol test, which he again refused to perform.

While in the jail, I read Mr. Barton his Miranda warnings which he indicated he understood and agreed to speak with me. When asked about him not stopping to law enforcement lights and sirens he responded that he did not know that we were trying to pull him over. I told him that he was the only vehicle on the road at the time of the incident and while attempting to stop him that another deputy pulled up to his driver side mirror to make sure you knew that you were being pulled over. Mr. Barton still denied not knowing he was being pulled over. When I asked Mr. Barton about him leaving the scene of the crash, he stated that he did not know that he was involved in a crash.

NARRATIVE

On March 22, 2026 at approximately 2330 hours, I, Deputy Gadacz observed a 2008 black BMW run a stop sign at the intersection of 32nd Avenue and 41st Street. I made a U-turn in an attempt to conducted a traffic stop. The vehicle appeared to be driving faster in attempt to lose me. I eventually was able to catch up to the vehicle and activated my patrols vehicle emergency lights at the intersection of 38th Avenue and 41st Place. The vehicle appeared to take off through the [REDACTED] and stopped at the intersection of [REDACTED] in front of [REDACTED]. I stopped my patrol vehicle behind the BMW and observed the passenger exiting the vehicle. I advised the passenger to get back into the vehicle and notified dispatch of our location.

I asked Zakelsha Santeria Williams, who was in the driver's seat to roll down the back window, due to it having dark tints. Williams rolled down the back windows and I then made contact with Williams at the driver's door. I asked Williams if she had her driver's license, registration, and proof of insurance for the vehicle. Williams provided her driver's license but advised she does not have registration or insurance because her passenger had just purchased the vehicle. I proceeded to ask Williams why did she not stop when I activated my emergency lights. Williams and her passenger advised they did not see me or my emergency lights until they were parked. I advised Williams the reasoning for the traffic stop. I informed her that I observed her vehicle run the stop sign on 32nd Avenue and she had a head light out. Williams advised she saw me pass her when she turned right off of 32nd Avenue and onto 41st Street. I then stated to Williams, "I thought you didn't see at me". Williams advised she did see me but was trying to get home. I asked where was she coming from and she advised she was coming from bowling in Vero Beach. While speaking with Williams, I noticed the odor of alcohol emitting from her and slurred speech. Once assisting deputies arrived on scene. I asked Williams to exit the vehicle and walk to the front of my patrol vehicle. While exiting her vehicle, Williams swayed and lost her balance. Once at the front of my patrol vehicle, I asked Williams if she was willing to perform some field sobriety exercises. Williams advised she will do the exercises and that she had nothing to drink.

Horizontal Gaze Nystagmus Exercise

Zakelsha Williams was instructed to follow the stimulus with her eyes only, keeping her head still. After stating that she understood the instructions, Zakelsha Williams attempted this exercise. After performing this exercise, I spoke with Deputy Chamberlain about the clues that I observed. Deputy Chamberlain explained the clues and the performance of the exercise. I was uncertain at the time and

Prior to the second attempt of this exercise, Zakelsha Williams indicated to Deputy Chamberlain, she did not have any medical problems that would have prevented her from performing the exercise. The results of this exercise displayed 6 of the 6 possible clues.

- A lack of smooth pursuit in the left eye
- A lack of smooth pursuit in the right eye
- A distinct and sustained nystagmus in the left eye at maximum deviation
- A distinct and sustained nystagmus in the right eye at maximum deviation
- An onset of nystagmus in the left eye prior to 45 degrees.
- An onset of nystagmus in the right eye prior to 45 degrees.

Walk and Turn Exercise

Prior to attempting this exercise, Zakelsha Williams indicated to Deputy Chamberlain, she did not have any medical problems that would have prevented her from performing the exercise. Zakelsha Williams was instructed to put her left foot on the line and her right foot in front of it with her right heel touching the toe of her left foot. She was instructed to stand in this manner with her hands to her sides until the exercise instructions were completed and the exercise demonstrated. While Deputy Chamberlain was giving Williams the instructions, Williams lost her balance several times and kept leaving the stance instructed by Deputy Chamberlain. Williams also kept starting the exercise before the demonstration

was completed. Williams also kept asking which foot needed to go first and kept switching the positioning of her feet. Williams was instructed not to begin the exercise until told to start. She was instructed to take nine steps along the line in a heel-to-toe manner. After the ninth step she was to stop and turn around keeping her lead foot on the ground, taking several small steps with the other foot to turn around. After turning around, she was to take nine steps in a heel-to-toe manner back along the line, in the direction she had come from. Zakelsha Williams was further instructed to watch her feet at all times while walking, keep her arms down to her side, and to count her steps out loud. After the exercise was demonstrated Zakelsha Williams stated that she understood the instructions and was instructed to begin the exercise.

The results of this exercise displayed 6 of the 8 possible clues:

She was unable to maintain her balance in the instructed position. She started the exercise several times while still giving her the instructions. During the exercise, she stopped once at the turn and asked if she was doing it right.

On the first set of steps, she took the correct number of steps. She did not touch heel-to-toe on steps 5, 6, 7, 8. She didn't step off the line.

She turned improperly.

On the second set of steps, she took the correct number of steps. She didn't miss any of the heel-to-toe steps. She stepped off the line on steps 3, 4, 6, 7, 8.

She used her arms twice for balance.

One Leg Stand Exercise

Prior to attempting this exercise, Zakelsha Williams was instructed by me to stand with her feet together and arms at her sides during the exercise. Zakelsha Williams was asked not to begin the exercise until instructed. She was instructed to raise the leg of her choice by approximately 6 inches off the ground.

While holding that position, she was to keep her leg straight and count out loud starting at one thousand one (one thousand one, one thousand two, one thousand three, ...) and so forth until instructed to stop (after 30 seconds). The exercise was demonstrated to Zakelsha Williams. After she indicated understanding the instructions, Zakelsha Williams attempted the exercise and raised her right leg and was wearing barefoot.

The result of this exercise displayed 3 of the 4 possible clues:

- Swayed during the exercise
- Used arms for balance
- Put foot down once during the exercise and when she was advised to continue. She did not continue where she left off and proceeded to count incorrectly.

Williams was taken into custody and transported to the Indian River County Jail for booking.

At the county jail Deputy Rodriguez #5661, requested Williams to provide a lawful breath sample. She refused to provide a lawful breath sample. Williams was read implied consent. Williams refused to provide a lawful breath sample again after being read implied consent.

Based upon the totality of the evidence, Williams was charged with FSS 316.193(1) DUI, and FSS 316.1939(1) – Refusal to submit to DUI Testing.

NARRATIVE

On March 22, 2026, at approximately 0058 hours, I was patrolling east on 8th Street, Vero Beach, Florida, as I approached 66th Avenue, I observed a blue Dodge pick-up bearing Florida tag DQ30MD in front of me apply the brakes.

When the brakes were applied as the aforementioned vehicle came to a stop at 66th Avenue, I observed the right rear tail light admitting white light, due to the red lens around the light being broken out, a violation of Florida State Statute; 316.224(3).

After observing the violation, I initiated a traffic stop at 800 58th Avenue, by activating the overhead emergency lights on my marked patrol car. The blue Dodge pick-up bearing Florida tag DQ30MD made a right hand turn onto 58th Avenue and proceeded south. The aforementioned vehicle slow rolled for approximately one thousand (1000) feet, before coming to a complete stop.

I approached the passenger side of the vehicle and made contact with the driver, Steven Shabdue, and the passenger, Sharon Teesi. I asked Steven for his driver's license, proof of insurance, and registration. While Steven was searching for his required documents, Deputy Ciofalo, and K9 Deputy Wolf arrived on scene.

I proceeded to my vehicle to conduct my traffic stop. While I was conducting my traffic stop, K9 Deputy Wolf deployed his K9 partner "Sunny" to conduct a free air sniff of the vehicle. K9 Deputy Wolf informed me his K9 partner "Sunny" alerted to the vehicle for odors he is trained to detect. See K9 Deputy Wolf's supplement report for full detail.

After issuing Steven a written warning for the violation of Florida State Statute, I began searching the vehicle. During my search, I lifted up the center consul, which separated Steven and Sharon. On Steven's side of the seat, where his cell phone was, I located a bag of a crystal-like substance, which based on my education and experience, I determined to be methamphetamine.

I walked to the front of my patrol car where Steven was sitting and asked him to stand up and placed him in hand-cuff restraints, checked for proper fit, and Deputy Ciofalo placed him in the rear of my patrol car.

I retrieved the bag of crystal-like substance from the vehicle and brought it to the rear of my patrol car. Utilizing an agency methamphetamine drug test kit, I conducted a field test, which provided a positive result for methamphetamine. I field weighed the methamphetamine, which weighed 5.01 grams with bag.

While I was conducting the field test on the methamphetamine, Deputy Ciofalo read Steven his Miranda rights, which he advised he understood.

Deputy Ciofalo brought me Sharon's purse, which we began to search, located inside were several torches (lighters), which are commonly used to smoke methamphetamine. Also located inside was Steven's wallet and a bubble (the street term used for the pipe to ingest methamphetamine). I told Deputy Ciofalo to place Sharon in hand-cuff restraints until we could figure out who everything belonged to, due to Steven's wallet being inside the purse.

I opened the rear of my patrol car, where Steven was sitting and informed him that I found a bubble in Sharon's purse, Steven immediately took ownership of the methamphetamine and the bubble. Steven informed me he suffers from chronic pain, and methamphetamine is the only thing that helps. Steven informed me he purchased the eight ball (street term for 3.5
