NARRATIVE

On Monday, May 18th, 2026, at approximately 1213 hours, I responded to the Indian River County Jail, 4055 41st Avenue, Vero Beach, FL, to investigate a battery against an inmate. (Statements are paraphrased)

Upon arrival, booking supervisors informed me that an inmate, named Wilmer Villalobos, struck another inmate.

Booking supervisors showed me the video, which showed Wilmer and the victim, named Andrew Montgomery, inside of [REDACTED] as cellmates. In the footage, which occurred on today's date at 0928 hours, Wilmer is sitting down on his mattress while Andrew is standing near the door. Wilmer appears to be arguing with Andrew, which is when he stands up and appears to move around the room aggressively and is still yelling at Andrew. Wilmer then strikes Andrew in the right side of his face. Wilmer continues to stand there and yell at Andrew for a few moments, which is when he strikes Andrew again in the same spot on his face. Medical Wing deputies arrive sperate the two. The video does not contain audio.

I walked over the Medical Wing and first spoke to Andrew, who was now separate from Wilmer. Andrew said their disturbance started over Wilmer urinating in the sink and he was asking him not to. That was when Wilmer walked over and struck twice in the left side of his face. I took a look at where Andrew was struck and notices some redness and a forming scab from being struck.

I approached Wilmer, who told me he was not willing to speak about the incident.

I charged Wilmer with violation of FSS 784.082 Battery on a Detained Person.



The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law:
 On _____, at _____ (Specifically include facts constituting cause for arrest.)

On 5/18/26 at approximately 0351 hours, I Ofc Kriegner, was sitting in my patrol vehicle facing east in the parking lot of the Shell Gas Station (1615 US1), when I observed a dark colored vehicle (grey Kia FL tag# RZYN79) traveling southbound on US1 with no lights on at an hour where it is required to have lights. I conducted a traffic stop on the vehicle in the 1400 block of US1.

Upon approaching the vehicle, I observed a male (Angom Phillipcan) driving the vehicle and a female passenger (Erika Stinson). I inquired the occupants about where they had been traveling from, Erika stated they were coming from the Palm Inn (2022 US1.) While speaking with the occupants, I detected an odor of marijuana emanating from inside the vehicle. I requested to search it, to which the occupants consented.

As I searched the vehicle, in a brown purse in the back seat, I located a glass pipe with dark residue inside it. I spoke with Erika, Post-Miranda, after she stated she understood and wanted to speak with me, who advised the purse was hers and that she had used the pipe to smoke crack cocaine. The inside of the pipe was field tested and showed a positive presence of cocaine.

Angom had no knowledge of the presence of paraphernalia in the vehicle and stated he had only known Erika for approximately 3 days.

Erika was placed under arrest for FSS 893.147 Possession of Drug Paraphernalia and transported to the Indian River County Jail.

The vehicle was released to the Angom.
 Photographs were taken and uploaded into Evidence Library along with my BWC.

NARRATIVE

On Monday, May 18th, 2026, at 0803 hours, I was dispatched to Cumberland Farms, located at 4490 US1, Vero Beach, Florida 32967, in reference to a report of criminal mischief.

Upon arrival, I met with Randolph Beasley and Lakiesha Anderson. Randolph and Lakiesha advised that they had just left 2610 42nd Street in Randolph's black 2008 Jeep SUV bearing Florida tag BY25ER due to Jerard Ross hitting the vehicle with a metal pipe, breaking the passenger front mirror. Randolph estimated the damage at \$500.

Randolph said while at 2610 42nd, Street he watched as Jerard fought with his brother, Anthony Judon. Randolph witnessed Jerard hit Anthony in the back with the metal pipe. Then Jerard turned his attention toward Randolph's vehicle. Jerard approached the vehicle where Randolph was occupying the driver's seat and Lakiesha was occupying the rear seat. Jerard was yelling that he was going to break out all the windows if they didn't leave the area.

Randolph felt like the threats were made due to him witnessing the fight between Jerard and Anthony, who were brothers. Randolph said Jerard took the pipe and smashed his passenger front mirror. Randolph said he immediately fled the area to Cumberland Farms [REDACTED]

Lakiesha said she also witnessed Jerard attacking Anthony with a metal pipe while setting in the back seat of Randolph's vehicle. She watched as Jerard then turned his attention towards Randolph's vehicle making threats to break out all the windows if they did not leave the area. She watched as Jerard swung the metal pipe smashing the vehicle's passenger front mirror. She said they immediately left the area and [REDACTED]

I was informed by Lakiesha and Randolph that Jerard stays at 2550 42nd, Street Apt C, which was just to the south of where the incident occurred. Deputy Q. Martin and I relocated to 2550 42nd, Street Apt C to attempt contact with Jerard. After knocking on the door, it was discovered he had already left the area. A short time later Lakiesha called back to dispatch advising Jerard had returned.

Upon arrival the second time, Deputy Martin and I made contact with Jerard who was inside 2550 42nd, Street Apt C. Jerard was cooperative and stepped outside the apartment. I advised Jerard of his Miranda Rights, which he indicated he understood and agreed to speak to us freely. I did not observe any visible injuries on Jerard's person.

Jerard admitted that he had gotten into a fight with his biological brother Anthony at 2610 42nd, Street. He said that his brother was battling addiction and he was simply trying to talk scenes into him. They began arguing and both started punching each other. The fight escalated into them both picking up objects to hit one another. Jerard admitted to hitting Anthony with the metal pipe in self-defense. Jerard denied

hitting Randolph's vehicle with the pipe advising that Anthony threw a metal wrench hitting it. Jerard denied ever approaching Randolph's vehicle.

While speaking to Jerard I observed Anthony nearby at 2610 42nd, Street. I went over and advised Anthony of his Miranda Rights, which he indicated he understood and agreed to speak with me freely. I observed that Anthony had a cut below his left eye and a cut on his right forearm.

Anthony said that he currently lives at 2610 42nd, Street and was approached that morning by Jerard, his brother. They immediately began arguing and then began fist fighting. Anthony said Jerard picked up a metal pipe and hit him under the left eye causing his facial injury. Anthony said he turned to runaway and Jerard hit him again in the right forearm with the pipe, causing his arm injury.

Anthony admitted he picked up a stick to defend himself, but never struck Jerard with it. Antony ended up running away from Jerard to avoid any further confrontation. I asked Anthony if he witnessed Jerard hit Randolph's vehicle with the pipe and he informed me he did not. I asked Anthony if he hit Randolph's vehicle and he informed me he did not.

NARRATIVE

On Monday, May 18, 2026, at approximately 1820 hours, I responded to 5555 77th Street, Hobart Park, in reference to a reckless driver.

While enroute, two separate complainants called 911 in reference to a black male driver operating a red Chevrolet four-door passenger car bearing FL tag EB37SK. Both complainants stated the driver was doing donuts in the gravel parking lot, speeding up to 40 or 50 mph, and continuously operating the vehicle without regard for his or anyone else's safety. The complainants stated this occurred on the dirt/gravel roads within the park, all within close proximity to an occupied playground. They additionally stated the reckless behavior was repeated multiple times prior to the vehicle leaving the park.

I arrived on scene and observed a red Chevrolet Cruze exiting the parking lot and turning west on 77th Street. I observed the vehicle was operated by a black male driver and the FL license plate (EB37SK) matched what had been described by the callers.

I affected an investigatory traffic stop on the vehicle and made contact with the male driver, Sean Aurthor Cody DOB 09/25/2003. His information was confirmed by his Florida ID card. A query of Cody through the Florida Driver and Vehicle Information Database (DAVID) confirmed Cody's driver license had been suspended since 09/12/2022 and he was issued a Florida ID card on 02/26/2021. Cody stated he knew he didn't have a driver license and was "just practicing". I received additional information from Indian River Public Safety Dispatch that Cody was on active felony probation for the following:

Case # 2201129 - 1 count of Burglary of an Unoccupied Structure/Conveyance,

Case # 2200962 – 3 counts of Burglary of an Unoccupied Structure/Conveyance and 1 count Felony Flee/Elude LEO.

Based on the aforementioned information, Cody was arrested and transported to the Indian River County Jail, where he was charged with the following offenses:

NARRATIVE

On Monday, May 18, 2026, at approximately 2032 hours, I, Deputy M. Neill #6317 responded to 699 17th Street , Vero Beach, Indian River County, Florida, in reference to Business Burglary in Progress.

The caller, who was the property owner, called in to report that a neighbor had called him about subjects breaking in to the location and destroying the property.

I arrived on the property and first observed Mr. Joshua Butcher yelling in to the stairway of the location. Mr. Butcher was addressed at gun point, due to the nature of the crime. Mr. Butcher came out towards the parking lot area and got on the ground.

During this time, Mr. Matthew Caldwell exit the stairway cutout and start walking towards me. Mr. Caldwell was told multiple times to stop walking towards me, turn around, and lay down on the floor. Mr. Caldwell ignored these commands multiple times until another unit arrived on scene and also addressed Mr. Caldwell with a Taser.

Ms. Shannon Fowler then exited the stairway cutout. She was ordered to get on the ground. She failed to listen to commands and walked toward us until she slipped in fresh paint.

While on the ground, Ms. Fowler and Mr. Butcher started to hug each other and hold each other after being advised multiple times to stop, and law down on their stomachs. Both subjects were almost apprehended by a police canine due to not listening or following commands.

All three subjects were taken in to custody and detained.

A sweep of the business was conducted and no other occupants were located. During the sweep, paint was located in the parking lot. It appeared that someone had just poured out fresh white paint. Additionally, there was an electrical closet which had a large whole in it. Within the electrical area, I located an electronic charging bank plugged in to the wall.

I made contact with the owner, Mr. Terence Schlitt. He advised that he owns the building. It is currently an office building that he is renovating. No one is supposed to be present at the location and no one has permission to be there, except for contractors. Mr. Schlitt advised contractors were last on property yesterday, but no one was present today working on the building. Mr. Schlitt believes the paint was located within the electrical room, but is not completely positive.

Deputy Coon advised Ms. Fowler of her Miranda Rights. She advised she understood her rights and was willing to speak to us. When I interviewed Ms. Fowler, she stated that charging bank belonged to her husband, Mr. Butcher. She advised that Mr. Butcher had to turn on the main power breaker in order for the outlet to work in the electrical room to work, in order so that he could charge the power bank. When asked what happened with the paint, Ms. Fowler advised that she found the paint located near the stairway and was "Playing with the paint".

NARRATIVE (Continuation)

I then spoke to Mr. Caldwell. He was advised of his Miranda Rights. He advised he understood his rights and was willing to speak to me. He advised that he has been staying here for a couple of days now, approximately a full week. During the time, he stays on the property but in the bushes, not near the actual building. While at the location today, he advised Mr. Butcher was "going nuts" and started throwing things around. He advised that Mr. Butcher threw a pallet from the stairway area towards the parking lot. Mr. Butcher also started throwing the white paint around, spilling it everywhere. Mr. Caldwell denied sleeping within the building location or charging any device in the structure. Mr. Caldwell also advised that he did not see Ms. Fowler throwing or messing around with the paint.

I then spoke to Mr. Butcher. He was advised of his Miranda Rights. He advised he understood his rights and was willing to speak to me. He denied charging any device within the structure and denied towing paint in the parking lot. He confirmed that he has been sleeping here for a couple of weeks, but did not damage or destroy anything.

It should be noted that Mr. Butcher and Ms. Fowler were both covered in paint. Mr. Caldwell was found to have paint on his fingers once I observed him again at the jail.

Mr. Schlitt estimates that the can of paint cost approximately \$50 to replace. He also estimates it will cost approximately \$2,000 to repair and clean up the paint spill.


Based on the above statements, and physical evidence on scene, all three subjects were within the curtilage of the structure, and were either present or were committing the criminal act of Theft (for stealing the paint) and Criminal Mischief (for throwing the paint on the parking lot). Based on this, I believe there is probable cause to arrest Mr. Caldwell, Mr. Butcher, and Ms. Fowler for Burglary of a unoccupied structure unarmed, pursuant to FSS 810.02.4a, Criminal Mischief Greater than \$1000, pursuant to FSS 806.13.1b3, Petit Theft, pursuant to FSS 812.014.3a, and Resisting an Officer Without Violence, pursuant FSS 843.02.

All three subjects were transported to the Indian River County Jail.

All three subjects were taken in to custody and detained.

A sweep of the business was conducted and no other occupants were located. During the sweep, paint was located in the parking lot. It appeared that someone had just poured out fresh white paint. Additionally, there was an electrical closet which had a large hole in it. Within the electrical area, I located an electronic charging bank plugged in to the wall.

I made contact with the owner, Mr. Terence Schlitt. He advised that he owns the building. It is currently an office building that he is renovating. No one is supposed to be present at the location and no one has permission to be there, except for contractors. Mr. Schlitt advised contractors were last on property yesterday, but no one was present today working on the building. Mr. Schlitt believes the paint was located within the electrical room, but is not completely positive.

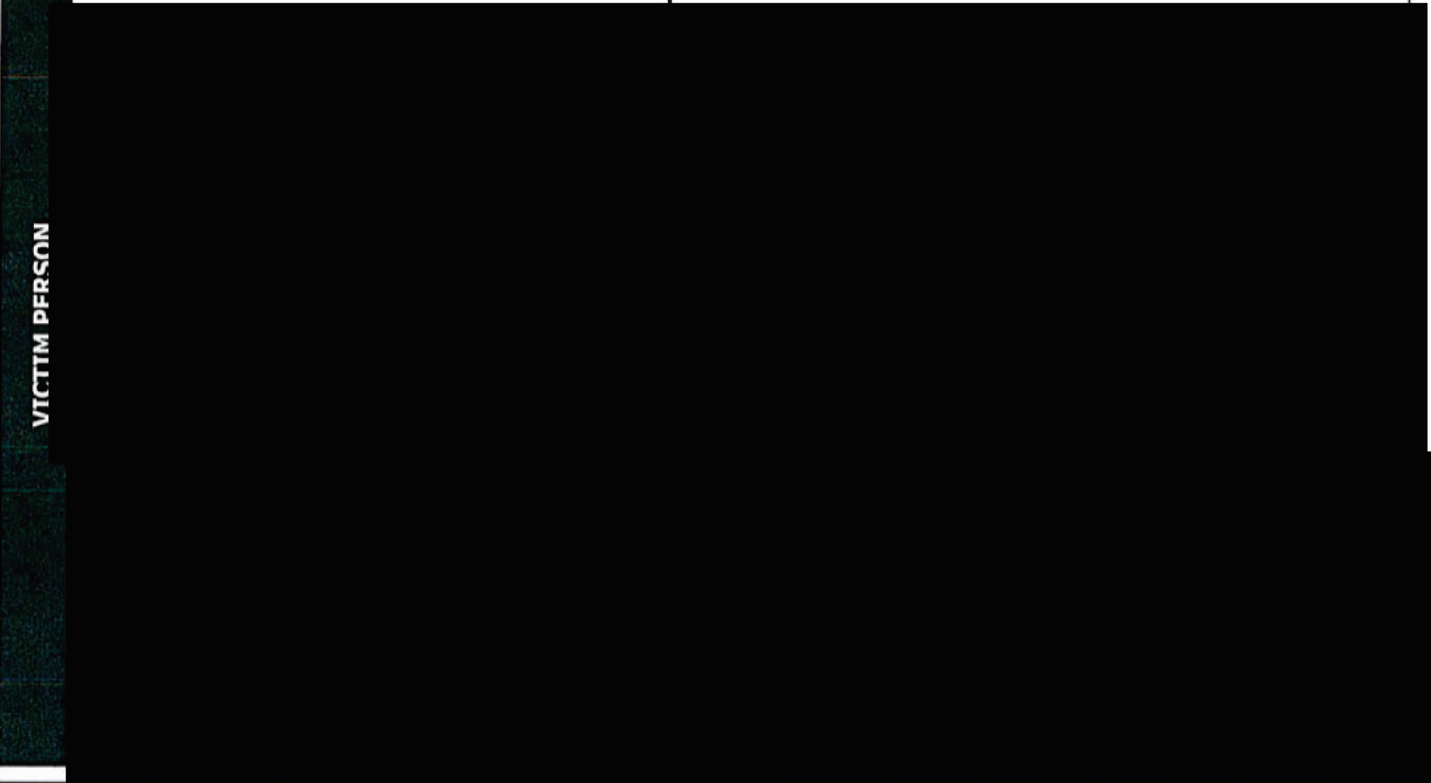

On May 18th, 2026, at approximately 2221 hours, I was dispatched to a physical disturbance at the residence of [REDACTED]

I arrived on scene and made contact with the complainant and witness, Natasha Celestin, who advised her [REDACTED] Emjay Snell and [REDACTED] were physically fighting. Celestin advised Emjay left prior to law enforcement arrival and wished to have him trespass. Celestin advised Emjay was upset about losing his phone and began arguing with [REDACTED] which in turn escalated to a physical altercation. Celestin stated they were wrestling with each other and Celestin had to break it up. Celestin stated Emjay then left outside the front door which [REDACTED] tried to follow behind. Celestin stated [REDACTED] then went out the side door and continued arguing with Emjay outside.

Emjay arrived on scene. I then spoke with Emjay who confirmed he did strike [REDACTED] first and stated his anger did get the better of him and was regretful. Emjay stated [REDACTED] was angering him by getting in his way and saying annoying things which caused him to become upset. Emjay stated he then grabbed [REDACTED] from the rear which caused [REDACTED] to then throw strikes at him back. Emjay stated Celestin got in between them breaking up the fight and he left the scene.

I did not observe any marks or injuries on Emjay.

I then made contact with [REDACTED] who stated [REDACTED] lost his phone and was trying to find it. [REDACTED] stated it then escalated to an argument in the living room and started to poke him in the head and call him a bitch. [REDACTED] stated [REDACTED] was not wanting to strike Emjay but though about it. [REDACTED] stated Emjay then got into [REDACTED] face while standing in the living room while arguing and Celestin got in between them. [REDACTED] stated Emjay then moved around Celestin and pushed [REDACTED] in the chest which caused the fight to start. [REDACTED] stated [REDACTED] retaliated by throwing an object at Emjay which then they started to wrestle. [REDACTED] stated Emjay at one point got on top of [REDACTED] while wrestling and choked [REDACTED] with his hands around [REDACTED] neck.
