#### NARRATIVE

On March  $17^{th}$ , 2025 at approximately 1605 hours, I responded to a call of the reckless driver. Public Safety Dispatch advised that a witness observed a vehicle traveling recklessly

The vehicle was described by witness Philip Kolar to be a white in color Ford pickup bearing partial Florida tag "71F" with the words "white pony" on the vehicle. Kolar stated to dispatch the vehicle was traveling all over the road and struck a guardrail near 66th Avenue and State Road 60. A FLOCK ALPR (automated license plate reader) captured the vehicle, a white in color Ford pickup truck bearing Florida tag 71FBAC with the words "white pony" scratched on the tailgate, traveling northbound on 66th Avenue and State Road 60 at 1551 hours.

Sergeant J. Kirby caught up to the vehicle as it was traveling north at the 4300 block of 66th Avenue and confirmed the Florida tag provided to dispatch, 71FBAC, and the "white pony" words which were on the tailgate. Sgt. Kirby then observed the vehicle weaving within its lane and at one point, enter the bicycle lane. Sgt. Kirby conducted a traffic stop on the vehicle at the 5700 block of 66th Avenue. Prior to my arrival, I spoke with Kolar via phone and he was unsure if the vehicle struck a guardrail or the tire struck a curb.

Upon arrival, I immediately began to inspect the vehicle for crash damage. I did not observe any crash damage to the vehicle. I then began to interact with the driver, who was already identified as Nelson Aguilar, date of birth January 19th, 1990 via his Florida driver's license by Sergeant Kirby. Deputy L. Mccullough was also on scene. Sgt. Kirby detected the odor of an alcoholic beverage emanating from Aguilar's person.

Aguilar admitted to drinking one and half beers earlier in the day and was merely tired.

As I began to interact with Aguilar, I detected the overwhelming odor of an alcoholic beverage emanating from his breath and person. I became concerned Aguilar was impaired beyond his normal faculties by alcoholic beverages or chemical or controlled substances. To dispel my concerns, I asked Aguilar if he would participate in a series of standardized field sobriety exercises, to which he agreed. Next, I asked Aguilar a series of medical questions to ensure he could participate in field sobriety exercises.

All field sobriety exercises were explained and demonstrated proficiently prior to Aguilar beginning each exercise and I confirmed he understood the instructions prior to the start of each exercise. Aguilar removed his sunglasses and I observed his eyes were extremely bloodshot and watery.

The following exercises were performed:

1.) HORIZONTAL GAZE NYSTAGMUS - No resting nystagmus was observed. Equal pupil size and equal tracking was observed in both eyes. I observed a lack of smooth pursuit in both eyes; distinct and sustained nystagmus at maximum deviation was observed in both eyes; the onset of nystagmus prior 45-degrees was observed at an

estimated forty degree angle. Vertical Gaze Nystagmus was not observed.

- 2.) WALK AND TURN A straight line of duct tape was used for the exercise. When asked, Aguilar agreed with me that the line was straight and flat. On the first nine steps, Aguilar missed heel to toe and stepped off the line. On the second nine steps, Aguilar missed heel to toe and stepped off the line.
- 3.) ONE LEG STAND Aguilar put his foot down, used his arms to balance and swayed while balancing.

Overall, Aguilar performed poorly on all field sobriety exercises.

Based upon my investigation, probable cause exists that on March 17<sup>th</sup>, 2025, Nelson Aguilar was in actual physical control of a motor vehicle while under the influence of alcohol beverages and/or a chemical or controlled substance and was impaired beyond his normal faculties, incapable of operating a vehicle safely.

Aguilar was arrested for DUI at 1640 hours and was advised of the charge. I took Aguilar into custody without incident and transported him to the Indian River County Jail for booking.

After I arrived at the jail, Deputy Sheriff Rudolph advised me that Aguilar agreed to provide a breath sample. At the conclusion of the test, the breath sample showed Aguilar had a breath alcohol concentration (BrAC) of .191 grams per 210 liters of breath and .188 grams per 210 liters of breath, an unlawful BAC.

D/S Mccullough conducted a vehicle inventory and discovered six "99 Proof" brand mini liquor bottles in the front seat. "99 proof" is an inexpensive alcoholic beverage with 49.5% alcohol by volume.

Based upon my investigation, I charged Aguilar with the following:

#### NARRATIVE

On Monday, March 17, 2025 at 1102 hours, I responded to the 100 block of 20th Avenue SW to assist Sgt D. Rodriguez on a traffic stop.

Sgt D. Rodriguez was traveling North on 20th Avenue SW when he approached a male and female riding bicycles. As he reached close proximity with the subjects, A loud audible "Bang" was heard which sounded similar to a gunshot. This drew Sgt D. Rodriguez to the male bicycle rider who was now visibly digging into his pants.

On my arrival, I observed both the male and female in the prone position next to their bicycles. I approached and while speaking to the male, I asked him if he had any weapons or sharp objects that would stick or poke me. The male who was identified as Hartley Sanchez stated he had two syringes in his left front pocket and a pocket knife in his right front pocket but no firearm. As I was patting Sanchez down for weapons, Sgt D. Rodriguez observed a small plastic baggy of a yellow rock like substance underneath the bicycle that Sanchez was riding. This substance was tested with an agency approved test kit and indicated a positive reaction to Methamphetamines. After a thorough search I revealed two unused syringes in the left front pocket of Sanchez along with two folded up pieces of aluminum foil. The aluminum foil when opened had a dark burnt residue on the inside. This aluminum foil along with the syringes and Methamphetamines are commonly used to prepare the drugs for intravenous injection.

read Sanchez his Miranda warnings and he agreed to speak with me. Sanchez stated that his drug of choice is in fact Methamphetamines however stopped short of admitting the baggy found under his bicycle was his. When asked if he was diabetic to explain the syringes he stated he was not.

Based on the totality, I found Sanchez in violation of FSS 893.147 possession of drug paraphernalia and FSS 893.13 possession of a controlled substance (Methamphetamines). Sanchez was issued Uniform Traffic Citation AJ5T24E for possession of a controlled substance.

transported Sanchez to the Indian River County jail without incident.

### NARRATIVE

On the afternoon of 03/17/25, I responded to the 9600 block of Water Vliet Avenue in reference to conducting a DUI investigation. Upon my arrival I made contact with Deputy Frank Scianimanico. He explained that the defendant had been involved in a crash in the city limits of Sebastian (SEBASTIAN PD CASE# 2025-0451), fled the scene and was involved in a second crash approximately fifty feet north of the intersection of CR 512 and Water Vliet Avenue. According to Deputy Scianimanico the defendant continued to drive northbound after striking the second vehicle and finally came to rest in the 9600 block of Water Vliet. Deputy Scianimanico stated the defendant was the only occupant of the vehicle when he approached it. He also informed me the second driver Mr. Carlos Garcia followed the defendant's vehicle to the point of final stop while speaking to was then informed the defendant was displaying indicators of severe intoxication such as strong odor of an alcoholic beverage emitting from his person and breath while very unsteady on his feet. He also admitted to drinking alcohol.

At the time of my initial arrival, I observed a white male sitting on the ground at the rear of a white Dodge Ram pickup whom I later learned was the defendant. I could see the defendant was swaying slightly while seated. As I approached the defendant to begin speaking to him, I could smell the strong odor of an alcoholic beverage emitting from his person from approximately two feet away. The odor got stronger as I got closer to him and began to speak to him at which time, I could smell it on this breath as well. As I began to speak with him, I noticed his speech to be slurred and mumbled. I explained to him that I would be conducting a DUI investigation and advised him of his Miranda Rights from a pre-printed card. He stated he understood his rights and refused to answer any questions.

I then asked the defendant to stand up at which time I observed that he was very unstable on his feet and had difficulty balancing himself. I instructed him to sit on the rear bumper of his truck to which he complied. I then conducted the Horizontal Gaze Nystagmus (HGN), while looking at his eyes I observed them to be extremely red, glassy, and bloodshot. I observed the lack of smooth pursuit in both eyes. I also observed the onset of nystagmus prior to forty-five degrees (approximately thirty degrees) in both eyes. There was distinct and sustained nystagmus present at maximum deviation in both eyes as well. Finally, I observed Vertical Nystagmus in both eyes as well.

asked the defendant to take two steps away from his truck which he was unable to do without being unsteady on his feet. For safety reasons I utilized alternative exercises to prevent the defendant from falling while attempting to walk as he was very unsteady.

The next task I asked the defendant to perform was to stand with his feet together and tilt head back while reciting the alphabet from the letter "E" to "P." When the defendant tilted his head back, he became unbalanced and nearly fell. He was unable to follow my instructions on two attempts. On each attempt he stated letters out of order and did not stop at "P."

The next task requested of the defendant was for him to count backwards from 87 to 68. He began by counting

The final exercise I requested the defendant was the finger count which I explained and demonstrated. I asked the defendant to start by touching his index finger to his thumb and counting "1," middle finger to thumb counting "2," ring finger to thumb counting "3," then little finger/pinky to thumb counting "4," then returning starting with his little finger/pinky to thumb "4," ring finger to thumb "3," middle finger to thumb "2," and ending with index finger to thumb "1." The defendant was unable to follow my instructions on two attempts.

I then placed the defendant under arrest and transported him to the county jail. Once at the jail he was requested to submit to a chemical breath test to determine its alcoholic content by Corrections Deputy B. Rudolph. The defendant submitted to the test and the results were .244 BrAC and .226 BrAC. He was further processed and held in lieu of a \$1,000 bond.


On Monday, March 17<sup>th</sup>, 2025 at approximately 1919 hours, I, Deputy Sheriff Ramiro Doval was attempting to locate a vehicle which Vero Beach Police Department BOLO'd (Be On The Lookout) out to Indian River County Sheriff's Office in reference to a stolen vehicle. The stolen vehicle was a Silver 2004 Honda CRV bearing Florida tag #BV88FP.

The last known location of the vehicle was westbound on 58<sup>th</sup> Avenue on State Road 60. I was stationary at the 8800 block of State Road 60 when I observed a matching description of the vehicle traveling westbound, coming to the intersection of 90<sup>th</sup> Avenue and State Road 60. Prior to getting behind the vehicle, I was advised the vehicle was being driven by Derek Gray, who was a habitual traffic offender.

I ran the tag on vehicle, IRCSO dispatch confirmed it was the vehicle.

As the vehicle passed me, I was able to get behind the vehicle and observe two occupants in the vehicle, a male and a female. I activated my emergency lights to conduct a traffic stop on the vehicle. The vehicle turned into Howard Johnson's parking lot and stopped.

I withdrawaled my agency issued firearm from my holster and pointed it towards the occupants of the vehicle and waited for backup units. Once units arrived, a felony stop was conducted and both subjects were removed from the vehicle and detained. The driver was later identified as Derek Ray Gray DOB: 11/16/1989. - Of 20 grams or less of a material, compound, mixture or preparation which contained cannabis, commonly known as marijuana, a controlled substance
- Contrary to Florida Statute 893.13(6)(b). (1 DEG MISD)



On 03/18/25 I, Ofcr. S. Gonzalez (471), was stationary on the shoulder at the intersection of southbound Indian River Boulevard and the Merrill P. Barber Bridge when I observed the Defendant drive past me traveling south in the curb lane.

What drew my attention to the Defendant's vehicle was that I observed that the left headlight was out and, as he passed me, I noted that the vehicle's tag light was out as well.

I initiated a traffic stop by activating the emergency lights on my fully marked police vehicle; final stop was on 21st Street and Indian River Boulevard.

I approached the Defendant's vehicle on the passenger side and upon arriving at the passenger door. Upon making contact with the driver, I immediately detected a very strong odor that based on my training and experience I recognized to be cannabis. In addition, I observed what I recognized to be 2 small "blunts" in a cup ash tray in the center console.

A "blunt" refers to a cigar hollowed out and filled with cannabis, as opposed to a joint which is typically rolled with thin, paper-like material.

I asked the Defendant for his license and registration which he was able to provide. I positively identified the Defendant as TERRANCE KENNARD HODGES by his Florida drivers license.

After confirming that the information on his license was current and correct and clarifying that the vehicle belongs to his mother, I asked the Defendant how much marijuana he had in the vehicle.

The Defendant stated that he only had the two blunts as he pointed to the cup ash tray in the center console.

I then had the Defendant exit the vehicle and stand on the sidewalk while I waited for an additional unit to respond. While waiting, I patted the Defendant down for weapons and found none.

I then engaged the Defendant with some small talk

I asked the Defendant where he obtained the cannabis and when was the last time he smoked. The Defendant stated that he had been at his cousin's house where he had obtained and had been smoking cannabis and that he had last smoked an hour prior to being stopped.

While speaking with the Defendant, he had his hands in his pockets and started reaching into the waist band of his shorts.

I instructed the Defendant to keep his hands out of his pockets and shorts. For my safety, I asked the Defendant to show me what he had in his pockets. Upon doing so, the Defendant pulled out what appeared to be several wrappers from the front pocket of the hoodie. However, I caught a glimpse of what appeared to be a greenish sandwich bag.

Based on my training and experience, I was aware that such sandwich bags are typically used to contain cannabis.

Upon closed inspection of the items, I observed that sandwich bag contained a green leafy plant-like material which I recognized to be cannabis a/k/a marijuana. When I asked him about the cannabis in the baggie, the Defendant stated that he got it from his cousin.

The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law:

I then detained the Defendant until an additional unit arrived to back me up. Ofcr. H. Hogue arrived on scene moments after I secured the Defendant and while I was escorting him to my vehicle.

A subsequent search of the vehicle yielded no additional drugs, however, I did locate a single 9mm hollow point round in the change holder of the center console.

I subsequently Mirandized the Defendant and he agreed to speak with me.

When I asked the Defendant about the round that I located, he stated that it belonged to his cousin who owns firearms and who had also been in his car earlier.

Based on a totality of the foregoing, I had probable cause to believe that the Defendant was in possession of less than 20g of cannabis and I informed the Defendant accordingly.

I made four attempts to contact the registered owner by telephone to give them an opportunity to retrieve the vehicle, however, my calls went straight to voicemail each time.

The foregoing occurred within the City of Vero Beach, Indian River County, Florida.

The Defendant was subsequently transported to the Indian River County Jail where he was turned over to the custody and control of the Indian River County Jail.

The vehicle was towed inventoried by Ofcr. Hogue and subsequently released to and towed from the scene by Jerry's Towing.

The foregoing was recorded with the use of in-car and body-worn cameras which were later uploaded to a secure server.

The Defendant was issued UTC AL1MB3E for the defective headlight and Criminal UTC AL1MB4E for Possession of Cannabis <20g.

Upon arrival, I made contact with Witness-1, Eduardo Serrano, who informed me that the residents down by had been in an argument with another resident over a package having been tampered with but that the incident had been resolved.

I then walked over to along with Ofcr. H. Hogue who had responded as backup.

I made contact with the Victim, Tina Hunt as well as Witness-2, Roger Nettles who were sitting in front of their respective units. The Victim stated that the Defendant came over and an argument ensued because the Defendant believed and accused Mr. Nettles of having tampered with a package that had been delivered and left at his door earlier in the day.

Ms. Hunt stated that, during the argument, the Defendant pushed her multiple times. Out of concern for her safety and to defend herself, Ms. Hunt retrieved a walking stick to ward off the Defendant who pushed her again before leaving and walking back to his apartment.

Mr. Nettles corroborated Ms. Hunt's statement regarding why the argument started and further stated that he saw the Defendant push Ms. Hunt and that, Witness-1 Mr. Serrano also witnessed the Defendant push Ms. Hunt.

Ofcr. Hogue and I then made contact with the Defendant at and asked him about the incident. After going off on a tangent about his service and life, the Defendant vehemently denied having pushed Ms. Hunt and claimed that the accusation was racially motivated and part of a concerted effort to get rid of him (kicked out of his apartment).

I left the Defendant with Ofcr. Hogue and K-9 handler Hatfield while I went to speak with Mr. Serrano a second time.

Mr. Serrano corroborated Ms. Hunt and Mr. Nettles' statements in that he stated that he was present during the argument and observed the Defendant push Ms. Hunt and that she retrieved her walking stick from her apartment and raised it in a cross-body defensive manner and that the Defendant pushed her again after she had retrieved her walking stick before walking back to his apartment.

Based on the totality of the foregoing, I had probable cause to believe that the Defendant committed the offense of Battery upon Ms. Hunt.

I then returned to the Defendant and took him into custody placing him under arrest. While taking him into custody, the Defendant tensed up and tried to pull away. However, after being warned not to resist, the Defendant was taken into custody without further issue.

The foregoing occurred within the City of Vero Beach, Indian River County, Florida.

The Defendant was transported to the Indian River County Jail where he was turned over to corrections personnel.
