NARRATIVE

On February 20, 2025 at approximately 0144 hours, I responded to Sebastian Gardens Inn and suites located at 14415 US Highway 1 unit 120, Sebastian in reference a miscellaneous.

Dispatch advised the complainant Alvino Dicarlo called in via 911 stating he was trying to get ahold of his wife. Dispatch advised they told Dicarlo he has been calling an emergency line multiple-times tonight.

Dicarlo called 911 on 02/19/2025 at 2043 hours (2025-00018651) in reference to a disturbance, where he claimed it involved his wife, who was not there, 02/20/2025 at 0018 hours (2025-0018700) in reference to a welfare check on his wife, who again was not there and had not been there all night, 02/20/2025 at 0113 hours (2025-00018707) in reference to a miscellaneous call, where he wanted us to locate his wife and at that time Dicarlo was told to not contact 911 unless he had an emergency. Dicarlo again called on 02/20/2025 at 0144 hours reference to wanting to call his wife.

Let it be known that the call on 02/20/2025 at 0113 hours, (2025-00018707) I advised Dicarlo that if he were to call 911 again and it is not for an emergency, he would be subject to arrest for misuse of 911.

Prior to my arrival to the third call for service involving Dicarlo, dispatch advised, Dicarlo called back into 911.

On my arrival to the scene, I knocked on the door and Dicarlo opened the door. I made contact inside unit 120 with Dicarlo who was standing up along his bed. I went to grab Dicarlo by his arm and he pulled away. His dog then started barking. Upon Deputy Holly's arrival I gave Dicarlo verbal commands to stand up from his bed. Dicarlo refused and I grabbed his right arm. Dicarlo then rolled onto his left arm. As I was attempting to pull Decarlo's left arm out from under him, Dicarlo started to actively resist by pulling his left arm away from me. I placed his right arm under my right knee and gained control of Decarlo's left arm. I placed Dicarlo into handcuffs, checked for proper fitment and double locked.

Dicarlo intentionally called 911 multiple times after being advised 911 was for emergencies only. I found probable cause to arrest Dicarlo for Misuse of 911 and Resisting Arrest Without Violence.

Dicarlo was transported to the Indian River County Jail Complex.

This incident was captured on my agency issued body worn camera.

NARRATIVE

On Wednesday, February 19, 2025, at approximately 1145 hours, Sergeant A. Scranton (5270) and I responded to 488 US Highway 1, Vero Beach, Indian River County, Florida, 32962, in reference to a trespass.

Upon arrival, contact was made with Mr. Robert Howden (Defendant), who was in the woods on the property. He had a knife and shovel with him, and appeared to be living on the property. A FCIC/NCIC query was conducted, which revealed the defendant was issued a written trespass warning regarding the property on December 1, 2024 (Reference CR#: 2024-00128597). Additionally, the defendant was located in the wooded area of the aforementioned property on December 4, 2024, at which point the deputy provided him another verbal warning to leave the property. The defendant was then located on the property again on December 5, 2024 (Reference CR#: 2024-00130126), at which point he was arrested for trespass after warning.

On February 19, 2025, the defendant was again located in the wooded area of the aforementioned address. It should be noted, the defendant had been issued at least one verbal warning, one written warning, and been arrested for trespass after warning, all regarding this location, within the past four (4) months.

Based on the above, it was determined:

The defendant did, without being authorized, licensed, or invited, willfully enter upon or remain in any property other than a structure or conveyance, the property of the victim, as to which notice against entering or remaining was given, either by actual communication or by posting, or fencing or cultivation as described in F.S. 810.011.

The defendant was taken into custody and transported to the Indian River County Jail without further incident.

NARRATIVE

On Wednesday, February 19th, 2025 at approximately 0138 hours I responded to 700 8th Court in reference to an agency assist. Vero Beach PD had conducted a traffic stop on a black 2015 Cadillac Escalade bearing FL Tag #QVGH03 that was suspected of having an impaired driver. Upon arrival Lt. Jaworski was standing by with VBPD Officer Sebastian Gonzalez.

Officer Gonzalez provided the following statement:

"On 02/19/25 I, Ofcr. S. Gonzalez (471), was contacted by my supervisor Sgt. F. Adamski (496) to alert me to a vehicle whose driver he suspected might be impaired.

Sgt. Adamski informed me that he observed a black Cadillac Escalade SUV traveling west on 17th Street and then south on Old Dixie Highway and that during his observation of the vehicle, he noted that the vehicle drifted within its lane and then abruptly correct back within the lane.

However, before I could arrive in the area, Sgt. Adamski informed me that the vehicle turned into the parking lot of Dom's Bar located at 1436 Old Dixie Highway and head towards the rear of the property.

Sgt. Adamski and I crossed paths at the intersection of 16th Street and Old Dixie Highway and were discussing the vehicle's driving pattern when it pulled back out onto southbound Old Dixie Highway; the time elapsed from the time it entered the property to when it pulled backout onto the road was approximately forty-five seconds to one minute and appeared to have been an attempt to evade or avoid being stopped.

I caught up to the vehicle and began my observations. The vehicle came to the intersection of southbound Old Dixie
Highway where I observed it enter the left turn lane and pause before continuing south on Old Dixie Highway from the left
turn lane. As I continued traveling behind the vehicle, I noted that the vehicle drifted within it's lane and abruptly corrected
it's course of travel multiple times.

I made contact with Cpl. M. Ruiz and informed him that I was behind a vehicle the driver of which I had a reasonable suspicion might be impaired. At Cpl Ruiz's behest, I initiated a traffic stop of the vehicle based on my observations as stated herein-above as it turned onto 8th Court off of 8th Street into the parking lot of Vero Strength and Conditioning located at 760 8th Court.

The vehicle parked in a parking space and as I exited my vehicle, the driver opened the driver side door and began to approach my vehicle. I instructed the driver to remain at his vehicle at which point Lt. Jaworski of the Indian River arrived on scene.

I informed Lt. Jaworski of my observations at which point he made contact with the driver. Upon making contact with the driver, it was determined that there was a firearm in the vehicle so Lt. Jaworski asked the driver to exit the vehicle and stand by the front my vehicle.

NARRATIVE (Continuation)

During his conversation, I could detect a strong odor of an alcoholic beverage emanating from the driver's breath. Cpl. Ruiz arrived shortly thereafter at which time I informed him of my observations as well as my being able to smell the odor of an alcoholic beverage emanating from the driver's breath."

I made contact with the defendant Alejandro Manuel Vergez. Vergez was leaning on Officer Gonzalez patrol vehicle. Vergez stated that he was driving around looking at the activity at bars in order to determine where he wanted to go. He had driven by Dom's Bar and was coming to the Speak Easy bar located near the traffic stop. While Vergez was speaking his speech was slurred. Vergez had bloodshot and watery eyes. I could smell the odor of an alcoholic beverage emitting from Vergez breath as he spoke. I asked Vergez if he was a diabetic or epileptic, he stated that he was not. I asked Vergez why I could smell the odor of an alcoholic beverage emitting from him, he stated that he had a Listerine strip earlier. Vergez denied consuming any alcoholic beverages.

I requested Vergez submit to the field sobriety exercises, he verbally stated that no. I informed Vergez that if he refused to submit to the field sobriety, I would have to base any potential arrest decision from my observations up to this point, he stated that he understood. I informed Vergez that if he refused to submit to the field sobriety exercises his verbal statement could be used against him, he stated that he understood. I again asked if he would submit to the field sobriety exercises, he stated no.

Based upon the totality of the evidence Vergez was taken into custody for violation of FSS 316.193(1) – DUI. He was transported to the Indian River County Jail for booking.

At the county jail Deputy Cuevas requested Vergez provide a lawful breath sample and he refused. He was read implied consent and he again refused.

On Wednesday February 19, 2025, while conducting stationary school zone speed enforcement I observed a red compact vehicle enter the posted 15 MPH school zone at 26 MPH. I observed the vehicle continue at the 26 MPH past my location at which time, I pulled out into the roadway and activated my emergency lights to conduct a traffic stop in the 3800 block of 16th Street in front of Rosewood Elementary. At this time, I provided Vero Beach Police dispatch with the Florida tag of 96EIVL and advised it was on a red Fiat. At this time, I approached the vehicle and observed a juvenile male in the backseat and a male in the driver seat who I later identified as Gabriel Ricuz Rivera by his Chilean passport. I explained the reason for the stop to Ricuz who, advised he did not see the flashing sign and was trying to get the juvenile to school. I asked Ricuz for his driver's license and paperwork for the vehicle at which time, he advised he did not have a DL but provided the vehicles registration that he advised belonged to his friend. At this time, I had the juvenile exit the vehicle and walk up to the school. I asked Ricuz why he did not have a DL and if it had been suspended to which he replied no he just did not have one. I advised Ricuz to call someone to come pick up the vehicle due to him not having a DL. I returned to my patrol vehicle and provided Ricuz's information to Vero Beach Police dispatch at which time they advised they were unable to find any information on him. I reproached the vehicle and asked Ricuz if he had any type of identification on him at which time he provided me with a Chilean passport. I asked Ricuz how long he had been in Florida and he advised a couple years at which time I asked why he had not obtained a Florida DL to which he replied he plead the fifth. I asked Ricuz if he was in the process of applying for a Florida DL at which time he again advised he plead the fifth. At this time, I had Ricuz exit his vehicle and stand in front of mine at which time I placed him under arrest for F.S.S. 322.03 NO DRIVERS LICENSE. Ricuz was transported to the Indian River County Jail without incident. Ricuz was issued two citations at this time, the first was for (AKDCK0E) F.S.S. 316.1895 SCHOOL ZONE SPEED, and the second (AKDCKNE) for F.S.S. 322.03 NO DRIVERS LICENSE. This incident was captured on my BWC as well as in car video.
