NARRATIVE

On July 8th, 2025, at approximately 0138 hours, I responded to the area of 5800 20th Street, Vero Beach, Florida, in reference to attempting to locate a female driving a white Ford sedan (bearing FL tag BG64DL).

A female complainant called in stating she was concerned for another female named Alexzandria Hall in reference to Ms. Hall telling her she was going to cut her wrists. A DAVID search revealed Ms. Hall has a white, 2013 Ford sedan (FL tag BG64DL). At approximately 0143 hours, the white Ford sedan was captured on FLOCK license plate readers traveling westbound on 20th Street from 58th Avenue.

I was in the area of 58th Avenue and 20th Street when I witnessed a white Ford sedan (bearing FL tag BG64DL) traveling westbound on 20th Street. As I was attempting to catch up to the vehicle, I witnessed the vehicle was unable to maintain a single lane.

I conducted a traffic stop on the white Ford sedan at the 7-11, located at 7400 20th Street, Vero Beach. As I approached the vehicle, I also witnessed two large spiderwebbed cracks in the center of the windshield and on the driver's side of the windshield that would obstruct the driver's view. I then made contact with the driver, and sole occupant, Ms. Hall. Ms. Hall appeared extremely sweaty – even with the vehicle's air conditioner on and cool. Additionally, she had exaggerated movements, appeared anxious, and seemed restless.

I subsequently requested Ms. Hall exit the vehicle. While speaking with Ms. Hall outside the vehicle, she had the same behavior. She also stated that she was not suicidal and did not wish to harm herself. Ms. Hall explained that she told her friend that she was because she wanted her friend to leave her alone so she could go to the Econo Lodge. I did not observe any cuts or injuries to Ms. Hall's person. I did not believe Ms. Hall met Baker Act criteria.

Based on my observations, I requested Ms. Hall complete Standardized Field Sobriety Exercises (SFSE's), to which she stated she would complete them. During the medical questionnaire, Ms. Hall stated she takes Alprazolam and utilizes medical marijuana. She stated she ingested both substance on the morning of July 7th. She stated she does not take any other medications and does not have any other medical issues.

The first exercise was Horizontal Gaze Nystagmus (HGN) exercise. I explained the instructions and Ms. Hall stated she understood and did not have any questions. During the exercise, Ms. Hall tilted her head to the side numerous times and continued to do so after being instructed not to. Additionally, Ms. Hall did not follow directions to follow my finger with her eyes and kept looking away from my finger.

The next exercise was the Walk and Turn exercise. I explained the instructions and demonstrated the exercise, and Ms. Hall stated she understood and did not have any questions. During the instructions, Ms. Hall was unable to keep her balance and also made a statement that she would be unable to complete the exercise "even if [she] was sober." During the exercise, Ms. Hall stopped, stepped off the line, missed heel-to-toe, and made an improper turn.

The third exercise was the One-Leg Stand exercise. I explained the instructions and demonstrated the exercise, and Ms. Hall

stated she understood and did not have any questions. During the exercise, Ms. Hall put her foot down, used her arms, and was hopping.

The fourth exercise was the Fingertip-to-Nose exercise. I explained the instructions and demonstrated the exercise, and Ms. Hall stated she understood and did not have any questions. During the exercise, Ms. Hall missed touching the tip of her nose, did not return her arm out to the side after touching her nose, and used her left finger when I advised to use her right.

Based on my observations, Ms. Hall was placed under arrest for the offense of DUI. She was placed into handcuffs that were checked for proper fit and double-locked. I then explained to Ms. Hall that if she has anything on/in her person, she will be charged with an additional offense if she brings it into the jail. Ms. Hall subsequently advised that she had a baggie of cocaine in her vagina; however, she could easily retrieve it. I brought Ms. Hall back to my patrol vehicle and concealed her so she could retrieve the baggie. Ms. Hall the produced a clear, plastic baggie containing a white, powdery substance. Based on my training and experience, I believed the white powder to be cocaine.

A search of the vehicle also revealed a small bottle of Fireball cinnamon whiskey, a cold Twisted Tea, and a cold boxed wine cooler. I also located another clear, plastic baggie with a white powdery substance residue in a black tri-fold wallet that was in the driver's seat where Ms. Hall was seated. The white, powdery substance in the baggie located on Ms. Hall's person weighed approximately five grams and field-tested positive for the presence of cocaine. The white, powdery substance in the clear, plastic baggie located in the wallet also field-tested positive for the presence of cocaine.

Ms. Hall was additionally charged with possession of cocaine (possession of a controlled substance). Ms. Hall was transported to the Indian River County Jail, without incident.

After arriving at the Indian River County Jail, booking staff requested Ms. Hall provide a breath sample; however, Ms. Hall refused. After being read Implied Consent, Ms. Hall refused again.

Ms. Hall was issued two citations for DUI (citation #: AJ8SZBE) and possession of a controlled substance (citation #: ADKMZYE), and she was issued a warning for the cracked windshield.

NARRATIVE

On Tuesday, July 8th 2025, at 0940 hours, I conducted a traffic stop on a Blue Toyota four door vehicle bearing Florida tag JXLL32, in the 3800 block of 49th Street. The reason for the stop, was due to the male driver not wearing a safety belt.

I made contact with black male driver, who was later identified as Marcus Alexander Williams via Florida driver's license. When I asked Williams if there were any illegal drugs in the vehicle, Williams admitted to having 14 grams of Marijuana on the floor board of the front passenger seat.

Upon searching the vehicle, I located a large white back on the front passenger seat floor board. Inside of the bag, was a large clear plastic bag containing Marijuana, a smaller plastic bag containing Marijuana, a large digital scale, and a box of clear plastic bags.

It should be noted that I located a lighter which resembled a small caliber Glock handgun, inside of Williams left pants pocket. A total of \$2038.00 dollars cash was also located between Williams' person and vehicle's glove compartment.

The Marijuana had a total weight of 22.44 grams without packaging.

I read Williams Miranda Rights warning. Williams advised that he understood. Post Miranda, I questioned Williams in reference to the Marijuana, individual plastic bags and digital scale which were all together in the white bag. Williams advised, that he understood what I was asking but that he was not trying to sell. Williams stated that he brings Marijuana to his friends.

Based on the facts listed above and Williams statements, probable cause did exist for possession of Marijuana over 20 grams, possession of drug paraphernalia, and possession with intent to deliver, sell Marijuana. Due to the fact that a felony amount of Marijuana was located, the individual packaging materials, along with the large digital and Williams' own admission. Williams was transferred to the county jail, without incident.

On Tuesday, July 8, 2025, at approximately 1942 hours, I, Deputy M. Neill #6317 responded to 4200 31st Avenue, Vero Beach, Florida, 32967 in reference to a theft.

Upon my arrival I made contact Mr. Michael Sears, who provided the following statement: Mr. Sears went and received groceries earlier today. When he got home, he placed them in to a freezer which is on the front porch of the residence, underneath the roof of the residence. Mr. Sears lives there alone. When he came back to the residence a neighbor informed him that Mr. Eric Jeanneau came by his residence unannounced. Mr. Sears checked and observed the groceries he purchased earlier today were now missing. The value of the groceries cost \$77.22.

Mr. Sears went on to explain how Mr. Jeanneau used to come by for work when he was there, but since learning about his past, no longer wished for him to be there. Mr. Sears provided a text message to Mr. Jeanneau which stated he is no longer welcomed on the property. Mr. Sears called Mr. Jeanneau to have him return since law enforcement was now present investigating the theft.

I spoke to a neighbor, Mr. Paul Benjamin. He stated that he observed an older model vehicle at the residence, which he knew is driven by Mr. Jeanneau. He observed Mr. Jeanneau at the property and knew that Mr. Sears did not want him around anymore. Mr. Benjamin called Mr. Sears and advised him of the situation. This is when he later discovered that a theft had occurred, and believed that Mr. Jeanneau committed the theft when he observed him at the property.

A short time later, Mr. Jeanneau returned to the property. During a non-custody interrogation Mr. Jeanneau admitted to taking food items from the residence earlier in the day. Mr. Jeanneau left a note behind (in Spanish) and a sunglass case (bag) which he stated symbolized he was going to come back in a couple of days and return the value of the objects taken. I attempted to conduct a post Miranda interview with Mr. Jeanneau. After being advised of his rights Mr. Jeanneau advised he no longer speaks English and only speaks Spanish.

Ms. Elaina Spangler provided the following statement: She arrived earlier with Mr. Jeanneau at the above residence. Mr. Jeanneau arrived and walked to the residence. He then walked back with some groceries. At the time she was unaware as to why they were there. She believed that he used to live there based on his actions. She confirmed that grocery items were taken by Mr. Jeanneau.

Mr. Jeanneau was then placed under arrest for the offense of Unoccupied Burglary of a Dweling Unarmed pursuant to FSS 810.02.3b, Grand Theft of Property from a Dwelling or Curtilage \$40-\$750 (It should be noted that the reporting software still says \$100) pursuant to FSS 812.014.2d, and for On Site Violation of Probation. Mr. Jeanneau is currently on Felony probation reference case number 2500050 for Battery upon person 65 or over.

NARRATIVE

On Tuesday, July 8th, 2025 at 2009 hours, I responded to Little Cesars, which is located at 755 27th Avenue Southwest in reference to a suspicious person incident. Prior to arrival, Public Safety Dispatch advised the complainant stated he observed a white female wearing a yellow tank top walking up to several cars in the front parking lot and pulling on door handles in the attempt to gain access inside.

Upon arrival, I located the aforementioned white female matching the provided description walking Southbound towards the Dunkin Donuts parking lot, located at 825 27th Avenue Southwest. I made contact with the white female and placed her in handcuffs. The white female was later identified as Tammy Murphy.

I was then advised by K9 Deputy Williams that he made contact with the witness, identified as Maximo Gallegos. Gallegos advised K9 Deputy Williams that he observed Murphy walk up to a black Nissan sedan, bearing Florida tag#X70SL, and pull on the front door handle, in the attempt to gain access inside the vehicle. Gallegos stated he then observed Murphy walk up and look into to several other vehicles in the front parking lot of Anytime Fitness, which is located at 755 27th Avenue Southwest.

I then made contact with the vehicle and identified the registered owner through a query via Public Safety Dispatch. The registered owner of the vehicle was identified as Javon Moore. I made contact with Moore and informed him of the situation. Moore stated he wished to prosecute. I then provided Moore with a victims rights brochure.

I then made contact with an employee inside the Anytime Fitness, who provided me with video camera footage of the incident. Through the video camera footage provided to me, I observed Murphy walk up to the driver side of the aforementioned Nissan sedan and forcefully pull on the door handle to gain access inside. I then observed Murphy continue to look into several other vehicles in the parking lot once she could not gain access inside the black Nissan sedan. The video camera footage was captured on my agency issued body worn camera.

I then made contact with Gallegos and provided him with a written sworn statement sheet, which he completed.

I then made contact with Murphy in the back of my marked patrol vehicle. I advised Murphy of her Miranda warnings, in which she acknowledged and continued to speak with me. Post Miranda Murphy stated she was looking into the vehicles of the parking lot because she could hear homeless people asking for help and because God told her to do so.

Murphy was then transported to the Indian River County Jail without further incident.

Due to the above mentioned, I criminally charges Murphy with the following charges:

NARRATIVE

On Tuesday, July 8, 2025 at approximately 2329 hours I was on routine patrol at 13527 U.S. Highway 1, Sebastian (Rack'M) in reference to driving up to an active disturbance. As I approached in my patrol vehicle I noticed a unknown white male later Identified as suspect, William Frederick Glavas, Jr. trying to open the front door of Rack'M.

I then looped around as I was flagged down due to Glavas, Jr. allegedly destroying the inside of Rack'M's.

I immediately called out a disturbance over the radio and then proned Glavas out at taser point. Deputy Mangle arrived on scene and handcuffed Glavas.

Glavas resisted while being walked back to my patrol vehicle with me having to use positive pressure pushing Glavas to the front of my vehicle. Glavas continued to try to move as he was being searched for weapons with me having to use my arm through his handcuffed arm for leverage to prevent Glavas from moving.

Witness/customer, Kenneth J. Pyle told me that Glavas had pulled the string lighting off of the wall/ceiling breaking the lighting system valued at approximately \$300.00.

Pyle also told me that Glavas told him to come here in the "dark hallway" and that he would kill him and everyone in the bar as Pyle tried to intervene. Glavas had on his person a buck knife with an approximate blade of 3.75" in his pocket.

Manager, Tabitha Cheyenne Shelanskey told Deputy Pollacek on scene that Glavas had also destroyed an approximately \$3000.00 Arcade Game, a Budweiser lighted sign valued at approximately \$300.00, a Blue Moon lighted sign valued at approximately \$200.00, a second lighted Budweiser sign valued at approximately \$149.00 and a security camera valued at approximately \$140.00. Total amount of damage was valued at approximately \$4089.00.

In addition to the damage to the facility Glavas also head butted my 2022 Tahoe front passenger fender valued at approximately \$1000.00. Glavas made an approximate 3/4"x2" dent in the fender.

Grand total damage was valued at approximately \$5089.00.

Glavas was heavily intoxicated smelling of alcohol, slurring his speech and acting erratic on scene.

When Glavas was inside the back of my patrol car he slipped his handcuff's to the front and started banging his head against the back glass. Due to Glavas behavior the Sergeant was called to drop off the "Wrap" system for unruly arrestee's securing them so the arrestee cannot hurt themselves or others.

It should be noted that Dibernardo is currently on probation for Felony DWLS until 02/14/2026, and listed as a Habitual Traffic Offender (Length: 5 years) since 01/16/2024.

After detaining Dibernardo, I searched her vehicle resulting in me locating a small plastic clear bag containing 2 peach colored, oval shaped, pills, later identified as Actavis (Buprenorphine Hydrochloride (Sublingual) 8 mg (base)). I conducted a search utilizing Drugs.com via Pill Identifier and confirmed that Actavis is schedule 3 controlled substance under the Controlled Substance Act (CSA.)

Through my investigation, I found Dibernardo to be in violation of FSS 322.34(5), reference DWLS/HTO (citation # ADKMYYE) & FSS 893.13, reference possession of a controlled substance (citation # ADKMZ0E).
