The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law:
 On 07/14/2025 , at 10:26 (Specifically include facts constituting cause for arrest.)

Defendant Merisena Luma Paul violated Florida State Statue 810.09(2)(a) by re-entering the Vero Beach Regional Airport after a verbal and written warning from the Vero Beach Police Department on May 9, 2025 and July 11, 2025. Paul was escorted off the property and advised she was trespassed and notified that she would not be able to come back on property for one year or she would be arrested.

On July 14, 2025 I responded to 3400 Cherokee Drive, Vero Beach, Florida 32960 within the jurisdictional limits of the City of Vero Beach in reference to a trespassing after warning. Upon my arrival I made contact with Merisena Luma Paul identified by her passport. I asked Merisena if she was aware that she was trespassed from the Vero Beach Regional Airport where she stated, "yes." Paul stated that she was at the airport because she had business to handle and because God told her too. Paul explained to that her husband Paul Clermont drove her to the airport. Paul and Clermont were seated upstairs in the hallway outside of the business office.

This officer does find probable cause for the arrest of Merisena Luma Paul for trespassing after warning on July 14, 2025.

Paul was handcuffed and transported to the Indian River County Jail without incident.

My BWC was active during this entire investigation.

On Monday, July 14, 2025, at approximately 0806 hours, I responded to Speedway, located at 800 US Highway 1, in reference to shoplifting. Upon arrival, contact was made with the complainant, Alexis Tyner.

Tyner stated a white male entered the store on two separate occasions in the morning and stole beer both times. The male was described as wearing a gray and black shirt, gray shorts, and black shoes. The male exited the store and left in a gray Ford Flex bearing Florida registration BV6-7XE.

I reviewed the surveillance video which showed the male first enter the store at approximately 0619 hours on the above date. The male is seen concealing a can of beer and exiting the store passing all points of final sale. The same male then came back to the store at approximately 0749 hours. The male is seen taking another can of beer from the cooler and concealing it in his pocket. The male then exited the store passing all points of final sale. The male was in the company of a white female, later identified as Jennifer Surgeon.

The items stolen were (1) 16oz can of Steel Reserve, valued at \$1.89, and (1) can of 25 oz Budweiser valued at \$3.19, with a total value of \$5.08.

The suspect was later identified as James Giddens, who was already on bond for felony theft. Giddens later responded to the Indian River County Sheriff's Office and stated he wanted to turn himself in for stealing beer. Giddens, who was wearing the same clothing and in the same vehicle as in the video, was detained and secured in the backseat of a patrol vehicle.

I made contact with Giddens, who spontaneously uttered he stole the beer and his girlfriend, Jennifer Surgeon, had nothing to do with it. Giddens was read Miranda warning from agency card, which he stated he understood. Giddens admitted to stealing the two cans of beer earlier in the day. Giddens stated he stole (1) can of beer the first time and came back shortly after and stole (1) can of beer again.

A criminal history query of Giddens produced multiple theft convictions. The two most recent felony theft convictions being 07/05/2017 and 02/06/2025.

Giddens was transported to the Indian River County Jail without incident, where he was charged with two counts of felony petit theft, 2 or more convictions.

NARRATIVE

On Monday, July 14th 2025 at 1135 hours, I conducted a traffic stop on a White Honda Pilot in the 3900 block of 66th Avenue. The vehicle was bearing Florida tag 1012TX. The reason for the stop was due to the driver of the vehicle not coming to a complete halt at the stop sign of 45th Street 38th Avenue.

I made contact with the driver, who was later identified as Steve Jerry Muller Septiembre. While speaking with Muller, I observed him to be visibly nervous as he stuttered his words and his hands visibly shook. I asked Muller if he had any weapons or illegal drugs inside of the vehicle. Muller advised that he had a pistol on his waistband. Muller further advised that he had a small amount of, "weed", inside of a white pizza box which rested atop of the front passenger seat.

It should be noted, while speaking to Muller I could smell a strong odor of Marijuana emit from inside of the vehicle. Muller was removed from the vehicle without incident, and a search of the vehicle ensued. Inside of the white pizza box, I located a clear plastic bag containing Marijuana, a plastic ashtray with Marijuana residue and a red grinder. The red grinder had Marijuana residue inside. I located a second clear plastic bag containing Marijuana on the driver's door storage compartment.

A prescription bottle was located on the rear driver side floor board. The prescription was for 90 pills of Amphetamine Salts 20MG (Adderall), and it was prescribed to a subject by the name of Marc Rudnick. The bottle had a total of 25 pills inside. The pink pills with indentation of, "E 344", were verified to be Amphetamines via Drugs.com, which is a schedule 2 controlled substance. Both bags of Marijuana combined had a total package weight of 93.96 grams.

I read Muller Miranda rights and he advised that he understood. Post Miranda, Muller advised that Marc Rudnick was an old roommate. Rudnick moved away and told Mullins to hold his medication for him. When questioned about the second bag of Marijuana, Muller denied having it inside of the car.

Based on the facts listed above, probable cause did exist for possession of a controlled substance, possession of Marijuana over 20 grams, and possession of drug paraphernalia.

Muller was transferred to the county jail, without incident.





NARRATIVE

On Monday, July 14, 2025 at approximately 0959 hours, dispatch/telecommunications received a BOLO (be on the lookout) from Sebastian Police Department. The BOLO was given the location of Schumann Drive/ US Highway 1.

Dispatch/telecommunications advised Deputies of the following:

"Sebastian PD attempted a traffic stop on a Silver Lexus SUV bearing FL tag #BH96FQ and the driver did not stop. Sebastian PD advised the driver is not the registered owner, however they know the driver to be Steven Soltysik".

I conducted a query on D.A.V.I.D (driver and vehicle information database) of Steven Soltysik to confirm his identity with a provided D.A.V.I.D photograph.

I began BOLO'ing the surrounding area and was advised a FLOCK LPR (license plate reader) located at CR510/US Highway 1 captured the aforementioned Lexus SUV bearing FL tag #BH96FQ traveling eastbound from the intersection.

I traveled to the Wabasso Causeway Bridge and observed the aforementioned vehicle parked in the causeway parking lot, 1820 Wabasso Beach Road. An Indian River Shores Officer informed Dispatch/telecommunications of the vehicle location. I activated my marked patrol vehicle #2210's emergency red/blue lights in an attempt to initiate a traffic stop on the occupant(s) of the vehicle. I observed the Silver Lexus SUV's reverse lights activate and advised Dispatch/telecommunications the vehicle was fleeing westbound over the Wabasso Causeway Bridge. At this point, I activated my lights/sirens on my marked patrol vehicle and the driver of the Silver Lexus failed to yield. The driver of the Silver Lexus SUV overtook another vehicle traveling westbound on the Wabasso Causeway Bridge at approximately 45-50 MPH. I advised on-duty supervisors of my ability to conduct a P.I.T (pursuit immobilization technique) maneuver in a safe location. I conducted my initial P.I.T. maneuver at Harbor Isle Way/CR510. This P.I.T maneuver was successful, however the driver restarted the Silver Lexus SUV and continued to flee westbound to the intersection of CR510/US Highway 1. I observed the driver of the Silver Lexus SUV demonstrate a willful and wanton disregard for the safety of persons and property while continuing to flee northbound from the intersection of CR510/US Highway 1 at a high rate of speed. At this point, the driver of the Silver Lexus SUV's speed was approximately 75mph in a posted 45mph zone. While approaching the 9000 block of US Highway 1, I attempted to conduct a second P.I.T maneuver. While next to the vehicle, the driver of the Silver Lexus SUV slammed on his brakes to a speed of approximately 45-50 mph, I also braked and conducted the second successful P.I.T maneuver.

The Silver Lexus SUV was completely immobilized and additional units arrived on scene to assist with the high-risk traffic stop. It should be noted, the driver and sole occupant, which I recognized as Steven Soltysik from my prior query on D.A.V.I.D was not compliant with law enforcement at the final resting position of the Silver Lexus SUV. Steven refused to listen to verbal commands such as showing his hands, rolling down the windows of the vehicle, and stepping out of the vehicle. After approximately 2 minutes of non-compliance, Steven Soltysik exited the vehicle with his hands up and was placed in handcuffs by additional Deputies on scene.

Fire/EMS arrived on scene to conduct a physical examination of Steven Soltysik. Rescue11 personnel deemed it necessary to transport Steven Soltysik to Sebastian Orlando Health Hospital, 13695 US Highway 1 for medical clearance. I traveled in the Rescue11 ambulance with Fire/EMS personnel to Sebastian Orlando Health hospital where I maintained custody of Steven



On 07/14/2025 at approximately 1742 hours, I Deputy Austin Binner responded to domestic violence disturbance located at [REDACTED].

Upon arrival, I spoke with the victim Davenport De Meyer. Mr. De Meyer stated he a verbal argument that had become physical with his fiancé, later identified as Jatriz Valiente. Mr. De Meyer advised both parties have been verbally arguing on and off over the weekend. Mr. De Meyer states the argument is over him potentially having a relationship with an unknown woman.

Mr. De Meyer showed a recording of the incident that was taken on his phone. The recorded incident is as follows. Ms. Valiente is sitting in a chair located in the kitchen of [REDACTED] while Mr. De Meyer stands approximately 10 feet away from Ms. Valiente. Ms. Valiente is yelling for Mr. De Meyer to leave, and both parties continue to verbally argue. Ms. Valiente begins to throw miscellaneous objects around the house in an uncontrollable manner, none of the objects were directly thrown towards Mr. De Meyer. Mr. De Meyer informs Ms. Valiente that one of the objects hit their pet dog (the video does not show the dog being struck, nor was there physical evidence to show the dog had any injuries or markings), and she continues to tell Mr. De Meyer to leave. While Mr. De Meyer walked backwards into another room to distance himself, Ms. Valiente stood up from her chair and approaches him. While continuing to yell at Mr. De Meyer, Ms. Valientes strikes Mr. De Meyer twice on his left arm with her fist closed. Shortly after being struck the video ends. Mr. De Meyer states he called for law enforcement to respond once the recording ended.

During questioning, Mr. De Meyer advised that this is a common occurrence between the two, with Ms. Valiente striking him when she becomes highly angry with him. He advised [REDACTED] and that they are engaged.

Post Miranda, Ms. Valiente stated she had let her emotions get the best of her. She stated that while both parties were arguing she became angry, and punched Mr. De Meyer in his shoulder.

Ms. Valiente was taken into custody and transported to the Indian River County Jail. Ms. Valiente is charged with the following.





NARRATIVE

While traveling eastbound on Oslo Road, I was passed by a red moped. As the moped was traveling in the outside lane it did not have a rear red running light (taillamp) functioning.

I made contact with the driver and sole occupant of the vehicle, who was identified as Mr. Brandon Pickett. He provided his Florida Drives license. Upon being asked if his license was valid, he stated no. Furthermore, he stated that he did not need a license since it was a moped and not a motorcycle. Mr. Pickett knew that his license was suspended due to a previous DUI and was using the moped as he did not think it required a license.

Per FSS 320.01, the moped is defined as a motor vehicle, which requires a valid Florida drivers license to operate it, not a motorcycle endorsement as it is under 50 CC's (Cubic Centimeters)

Upon checking FCIC/NCIC, I confirmed that Mr. Pickett did not have a valid Florida drivers license. His license was suspended on 09/07/2022 for DUI, reference citation number AAO5Q7E. On the same date, he was listed as a Habitual Traffic Violator for a period of 60.0 months. He has also received notice of this suspension by a court order or UTC.

Based on Mr. Pickett operating a motor vehicle as he knew his license was suspended, he was placed under arrest for Driving While License Suspended – Habitual Traffic Violator, pursuant to FSS 322.34.5, and for Possessing a Revoked or Suspended Driver's license, pursuant to FSS 322.32.1.

He was transported to the Indian River County Jail without incident.
