PROBABLE CAUSE STATEMENT

On 06/08/25, at approximately 2227 hours, I, Ofc Aguilar, responded to the area of 31st Ave and 20th St. in reference to a report of a subject breaking into a nearby business. On scene, I made contact with a rather not complainant, a white male, approximately 6-1 in height with shoulder length hair. The complainant directed me towards 3036 20th St. (Vero Dental Spa) and advised that he observed a male attempting to break into the property. The complainant advised the subject was a white male wearing a hat. The complainant stated that he wanted to remain anonymous and the left the area on foot.

I then walked along the north side of the above-mentioned property and observed a shattered glass door. As I approached the glass door, I observed a white male, later identified as Anthony Bonfiglio (will now be referred to as defendant 1 (D1), emerge from a nearby hidden corner. D1 was standing next to a partially open utility closet and was then placed into handcuffs pending further investigation. D1 was wearing a sleeveless camo shirt, camo pants and wearing a baseball cap.

After observing three additional broken windows on the west side of the business, D1 was read his Miranda Warnings, which he understood and agreed to answer my questions. D1 stated that he panicked at the sight of law enforcement and was attempting to avoid police. D1 stated that he was just trying to find a place to sleep and that he was unsure how the windows to the property were broken. D1 stated that he did know the complainant and would rather not say if he was involved in the incident.

The manager of the property, Megan Mashnouk (will be referred to as additional (A1) responded to the scene and attempted to inform the owner of the property Jay Ajmo (will be referred to as Victim V1). We conducted a walk-through of the property with A1 and entered from that shattered glass door near where D1 was detained. Behind the shattered glass door, a palm-sized rock was observed on the floor consistent with it being launched at the glass door from outside. The rock was submitted into evidence.

V1 was later contacted and informed me that he did have access to the video surveillance of the property. I explained the incident to V1 who wished to pursue criminal charges for the damaged property and valued the windows at approximately \$2500.00.

V1 later stated that he was having issues reviewing the video and would require his IT person to access the video the following day. V1 stated he would contact the Vero Beach Police Department with the video findings.

D1 was on property at a time unusual for law-abiding individuals and was not part of any official business. D1 also was also attempting to conceal himself at the sight of law enforcement and due to the circumstances; there was a reasonable alarm for the safety of property in the vicinity. D1 was charged with violation of F.S.S. 856.021 Loitering or Prowling and then transported to the Indian River County Jail without further incident.

Photographs/body camera video of the incident was submitted into a secure file.

On 06/10/25, at approximately 1140 hours, I, Ofc Aguilar, received video surveillance regarding case report (2025001128) which occurred at 3036 20th St. (Vero Dental Spa) on the night 06/08/25. During this incident, Anthony Bonfiglio (will now be referred to as defendant 1 (D1), was arrested for loitering and prowling after he was located behind the business after normal operation hours. Multiple broken windows were observed which D1 denied having knowledge on how they were broken. D1 was wearing a sleeveless camo shirt, camo pants and wearing a baseball cap during this incident. See the above-mentioned case report for further information.

The manager of the property, Megan Mashnouk (will be referred to as additional (A1) provided me the following security

video, which was uploaded to evidence. I observed the following: The camera is labeled as (Back Entrance) and shows a point of view near the broken back door near where D1 was located during the arrest. On 06/08/25 at approximately 2226 hours, D1 is observed on video wearing the same camo clothing and baseball cap and approaching the rear door of the business. D1 then walks up to the rear door and (pulls on door handle) attempted to open it with no success. D1 then looks into the business and then down towards a pile of rocks to the right. D1 then bends over and appears to pick up rocks and then looks back. D1 then walks out of camera view and then returns with an item in his right hand (appears to be a rock). D1 then throws the item at the back door (repeats this five times). D1 then bends over to the pile of rocks once again and throws another rock at the back door. D1 then reaches through the broken glass door and appeared to be manipulating the locking mechanism from the inside. D1 pulls on the door from the outside and is unable to open. D1 then pulls out his phone and activates his phone flashlight. D1 then bends over again and retrieves another item. D1 then utilizing the unknown item and phone flashlight makes an attempt to pick the lock on the back door. D1 has no success, then pulls out his wallet from his back pocket, and retrieves another item. D1 once again attempts to manipulate the locking mechanism on the rear door while pulling on the door handle. D1 is unable to make entry.

I then observed video surveillance from a different angle (labeled rear walk) also depicting the rear door and a nearby utility closet. This angle shows D1 inside the nearby utility closet at approximately 2230 hours and myself arriving on scene utilizing my flashlight. D1 then exits the utility closet with the flashlight on his phone illuminated and is still unnoticed by responding officers. D1 is then spotted in the corner and comes out with his hands in the air. D1 complies and is then detained.

Based on the circumstances in this case, D1 will also be charged with violation of F.S.S. 806.13 (Criminal Mischief damage over \$1000.00 and F.S.S. 810.02 (1a) Burglary.

On 06/10/2025, at approximately 22:00 hours, I observed Alvin D. Moore (B/M DOB:12/23/1983) standing by the wooded area located along 10th Avenue and 14th Lane. Alvin was mounted on a red Schwinn bicycle, and a few feet away by the woods was a silver Schwinn tricycle with no one nearby. Alvin would direct his attention towards the wooded area multiple times, monitoring something. I had existing knowledge that this wooded area led to the restricted FEC Railroad, and just beyond was more wooded property (belonging to the City of Vero Beach with no trespass signs posted). This area has an ongoing problem with homeless camps and various crimes that are committed within the woods.

I remained within the area and at approximately 20:35 hours, I observed Alvin Moore and Mark B. Miller (W/M DOB: 11/08/1982), traveling westbound on 16th Street from 10th Avenue. It should be noted that I was able to recognize and identify both subjects from previous law enforcement encounters. Mark was driving the silver Schwinn tricycle that I observed by the woods, and Alvin was driving his red Schwinn bicycle, while simultaneously steering a third mountain bike along the side of with him with his arm extended out.

I observed that the subjects did not possess any lights affixed to any of the bicycles, and I conducted a traffic stop on the subjects for the offense. I explained to them the reason for the stop, along with my observations of them loitering by the woods earlier. During my initial contact, Alvin claimed ownership of the red Schwinn bicycle he was riding. Mark claimed that he was the owner of the mountain bike that Alvin was steering. Mark then told me that he retrieved this mountain bike from the woods located by the railroad track. He advised me that the silver tricycle that he currently was in possession of belonged to a friend of his. Mark then provided me with a story on how he obtained the tricycle. Mark's story did not make sense, and he would change the story while trying to explain it to me. Mark told me that earlier today he saw that his "friend" and the rightful owner of the tricycle was arrested on the Indian River County Sheriff's Office web site. Mark then somehow located the tricycle and decided to take the tricycle so he could watch the tricycle for the friend. Mark struggled to recall the name of this "friend", but I was later able to identify the owner of the tricycle as Lesa Riffey (further referred to as V2) after searching through the bookings photographs and locating her. Mark also confirmed the identity by viewing the photograph. While talking to Mark, he became very nervous and failed to dispel my suspicion regarding him loitering and being in possession of property that did not belong to him. Mark began to sweat and move around a lot, especially when I inquired if he had any weapons or illegal items on his person. At this time, Mark was detained in handcuffs and placed into my patrol vehicle. I advised Mark of his Miranda warning, and he said that he wished to talk to me.

Post-Miranda, Mark advised me that he has not had any form of communication with V2. Mark advised me that he did not gain possession of the tricycle from the rightful owner but claimed that the owner would be okay with him watching the tricycle for them. When I asked Mark how he got the tricycle, Mark told me that he observed the tricycle unattended earlier in the day near the Walgreens located at 1705 US-1. Mark then retrieved the tricycle and maintained possession of the tricycle.

I then spoke to Alvin and advised him of his Miranda warning. Post-Miranda, Alvin advised me that just before Mark and him were at the wooded area on 10th Avenue, Alvin ran into Mark at the Walgreens at 1705 US-1. At the Walgreens, Mark asked Alvin to help him retrieve a mountain bike from the woods on 10th Avenue. Mark wanted Alvin to help him bring the bicycle back to a camp. Alvin agreed to help Mark, and Alvin had the impression that Mark was retrieving a bicycle that belonged to him.

At this time, V2 was still incarcerated and had been incarcerated since the early morning hours of 06/10/2025. Mark stated that he retrieved the tricycle from Walgreens earlier, and he claimed that the tricycle was otherwise abandoned. I observed that there was a basket on the back of the tricycle that had a large black backpack and a large Styrofoam cup from Cumberland Farms. The Styrofoam cup was still cold with condensation, and there was ice water contained within. I asked Mark if the cup and the bag were his or if it belonged to V2. Mark denied ownership and told me that it must belong to V2. I intended on safely storing the tricycle at the Police Department until I could verify the credibility of Mark's claims, and because Mark verified that the property did not belong to him. I then inventoried the backpack and located several tools, gloves, a blonde wig, electronics, men's shaving blades, and a small black travel bag located inside the backpack. Inside this

smaller travel bag, I located:

- A sock that was concealing a glass smoking pipe with burnt residue. The burnt residue of this pipe was collected with a cotton swap and the residue field tested positive for the presence of Methamphetamines.
- A small plastic baggie with crystal-like substance contained inside. The crystal substance field tested positive for the presence of Methamphetamines. The total package weight of the crystal with the Ziploc bag was approximately 0.18 grams.
- A digital scale was stored inside the bag, right next to a large amount of small resealable Ziploc baggies. I recognized the combination of these items to be commonly used to sell, use, and distribute illegal narcotics.

I noted that the contents of the bag were more consistent with the belongings of a male. This bag was stored on the tricycle, right next to the Styrofoam cup that was still cold. Mark was in possession of the tricycle and the backpack that was stored behind the seat of the tricycle. Based on these facts, I found Mark to be in violation of FSS 893.147(1) Possession of drug paraphernalia, and violation of FSS 893.13(1A1) Possession of Meth with the intent to distribute (FL UTC #AL1MNYE). I placed Mark under arrest and transported him to the Indian River County Jail.

Once at the jail, I was able to conduct a separate interview with V2. V2 verified that they were the owner of the Schwinn tricycle. V2 advised that they left their tricycle with a friend who was an older male with short hair, blue eyes, and a "potbelly". This older male was supposed to keep V2's tricycle for safe keeping when V2 was arrested near 12th Street and US-1. I asked V2 if the defendant, Mark, ever had permission to possess or use the tricycle. V2 was unsure who "Mark" was and advised me that the defendant did not have permission to use or possess the tricycle. I showed a photograph of Mark and V2 recognized Mark as a homeless subject that was local to the area. V2 again verified that Mark did not have authorization or permission to use or possess the tricycle. V2 advised they were willing to prosecute for the offense. I then asked V2 about the contents of the backpack recovered. V2 stated that a smaller bag with tools belonged to V2. V2 advised that they were not the owner of the large black backpack that was recovered. V2 informed me that the blonde wig, the small travel bag with the digital scale, and the shaving blades did not belong to V2. I concluded my interview with V2.

I recalled that earlier Mark stated he retrieved the tricycle when he observed it unattended near Walgreens. The tricycle was never transferred to Mark, and he did not have any permission to take the tricycle. Mark knowingly and unlawfully obtained and used the tricycle. Mark did so with the intent of appropriating the property for his own personal use. The tricycle was gifted to V2, and it is unknown what the true value of the property is. The Schwinn tricycle has a current retail value of approximately \$55.00 in US currency.

I conducted a records check on Mark and discovered that he has a lengthy criminal history with two or more prior convictions for theft. The first conviction was listed for Grand Theft more than 300 less than 5000 (dated 09/23/2008), and the second conviction was for Petit Theft Merch/Farm/Transit with two or more prior convictions (dated 09/23/2008). Based on the totality of the above, Mark was also charged in violation of FSS 812.014(3C) Petit theft second degree (third subsequent offense) a felony of the third degree.

Mark was then turned over to the Indian River County Jail for booking and processing.
